RE: PROVISION OF HEALTH SERVICES OUTSIDE BURNABY

PURPOSE: To obtain Council's authority to allow Health Department staff to provide health services to students of the Provincial School for the Deaf who reside outside Burnaby.

Recommendation:


1. THAT the City Clerk be given authority to execute an agreement with the Board of School Trustees of School District No. 41 to allow health staff to deliver health services to students enrolled in the Jericho Hill Provincial Resource Program.

REPORT

The Provincial School for the Deaf has been transferred to Burnaby and Burnaby Health staff provide services to the Jericho students. From time to time, it is necessary for staff to visit the students or their care-givers outside Burnaby, either in the residence, which is still in Vancouver, or in their own homes.

A section was included in the Municipalities Enabling and Validating Act enacted by the Legislature in July (see attached) to allow Burnaby to provide services to these students outside the municipality.

The Burnaby School Board has written to us (see attached) requesting that these services be provided. It is therefore proposed to enter into an agreement to allow staff to visit students at their homes or at the residence in Vancouver when necessary to supply health services.

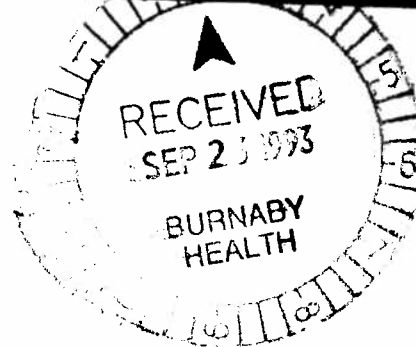

Dear Lynda,

Reference is made to our recent discussion regarding health services for students at the Jericho Residence. As indicated, health services must be provided from time to time outside the District for students of the Provincial School for the Deaf. In some cases the student may live at home or in the Jericho Residence, either of which may not be within the City of Burnaby.

The health staff involved in providing such services are two community health nurses, a rehabilitation therapist and a nutritionist. The funding for this service is provided by the Ministry of Education to the Burnaby School District, which in turn will provide funding to the City of Burnaby for the provision of those health services required.

In accordance with Section 19 of Bill 12, the Burnaby School District requests that the City of Burnaby provide health services to students of the Provincial School for the Deaf outside of the City of Burnaby, as jointly agreed upon by the School District and the Burnaby Health Department.

Regional District of Fraser-Cheam: Hope Airport transfer

- 18.** Despite section 535 of the *Municipal Act*, the Regional District of Fraser-Cheam may enter into an agreement with the Government of Canada that provides for ownership of the Hope Airport to be transferred from the Government of Canada to the regional district and that includes an option for the Government of Canada to repurchase the transferred property from the regional district.

Burnaby services to Jericho Hill School

- 19.** (1) The City of Burnaby may, by agreement with the Board of School Trustees of School District No. 41 (Burnaby), provide health and social services to the students enrolled in the Jericho Hill Provincial Resource Program, whether those services are to be provided within the municipality or outside the municipality.
- (2) All resolutions and bylaws in relation to the services referred to in subsection (1) are confirmed and validated, effective the date on which they were adopted to the extent they would have been valid had subsection (1) been in force on the date they were adopted.
- (3) The City of Burnaby is conclusively deemed to have had the authority to enter into an agreement referred to in subsection (1) at the time at which the agreement was entered into, to have had the authority to adopt a resolution or bylaw referred to in subsection (2) at the time it was adopted and to have had and continue to have the authority to carry out the agreement.
- (4) This section shall be deemed to have come into force on September 1, 1992 and is retroactive to the extent necessary to give it effect on and after that date.
