The Union wishes Council to be aware of its position that the proposed changes to the #120 route are vague in that very little detail is provided in order to justify the discontinuation of the #120 route and replace it with a #12 route which would provide an express service along Broadway. The speaker questioned the validity of Transit's suggested increase in service hours and urged Council to recommend that B.C. Transit conduct a "user" survey in order to provide accurate figures on ridership and to better address public need for transit service.

In concluding, Mr. Mullan advised that the Independent Canadian Transit Union supports the S.F.U. and Montecito service but rejects the remainder of the plan for changes to the North Burnaby/Hastings Street service.

The writer indicated that similar laws have been enacted in San Mateo, California and King County, Washington and felt it was time that Burnaby demonstrated the same responsibility.

Item 4, City Manager's Report No. 9, 1993 February 08 was brought forward for consideration at this time.

 Letter from Ms. Barbara Bradey, 7450 Second St., Burnaby, B.C., Regarding Mandatory Spaying and Neutering of Pets

The City Manager submitted a report from the Director Finance in response to the correspondence from Barbara Bradey regarding mandatory spaying and neutering of pets in Burnaby. Staff indicate that steps have been taken to promote responsible pet ownership including support of the S.P.C.A. educational programs and a reduced dog licence fee for spayed and neutered dogs. As a result, the pet surplus in Burnaby has been diminishing to the point where only two litters of puppies spent time at the Animal Sheiter in 1992 and all were adopted. Given the success of the current educational approach to responsible pet ownership, staff indicate that the adoption of a mandatory spay and neuter bylaw does not appear warranted at this time. Staff will continue to work with the S.P.C.A. in promoting responsibile pet ownership as this approach has proven to reduce the surplus pet population situation in Burnaby.

The Plan reviews the options available for meeting expected electricity requirements for B.C. Hydro's customers over the next 20 years. It also proposes a possible schedule for the acquisition of resources to meet those needs. The writer further advises that the Electricity Plan is necessarily subject to revision as changes occur in technology, the economy, environment and socio-economic perspectives or any other primary drivers (such as population increases) that influence supply-demand balance.
