The City Manager submitted a report from the Director Engineering requesting Council authority to expend \$40,000 for engineering services to service City subdivision #102/93 in Cariboo Heights located at Mona Avenue and Klenner Drive. Servicing of this extension will provide 23 lots available for sale. There are currently no serviced lots remaining unsold in Cariboo Heights and therefore the design of services for the subdivision is proposed so that lots could be on the market by late summer.

The City Manager recommended:

1. THAT Council authorize the expenditure of \$40,000 for the provision of engineering services for the servicing of City subdivision #102/93 in Cariboo Heights.

Rezoning Reference #72/93

The City Manager submitted a report from the Director Planning and Building providing Council with information regarding the relevance of B.C. Human Rights Legislation to the inclusion of a guideline in the Comprehensive Development District zoning ensuring that there are no age restrictions placed on persons residing within a townhouse development.

The City Solicitor has advised that while neither the Federal nor the Provincial Human Rights Acts prohibit discrimination on the basis of age or family status in the sale of land, neither do they establish the right to do so. As a result, the Solicitor advises that the legislation does not prevent property controls in the form of prohibition of such discrimination being validly effected through the Comprehensive Development zoning process as has been proposed in the subject case.

The City Manager recommended:

3. British Columbia's Protected Areas Strategy (PAS)

The City Manager submitted a report from the Director Planning and Building providing Council with information about the Provincial government's Protected Areas Strategy and to nominate Burnaby Mountain Conservation Area as a candidate site.

British Columbia's existing system of protected areas consists of ecological reserves, Provincial Parks and National Parks. These lands and resources may not be sold nor is resource extraction or industrial development permitted. Presently, approximately 6% of the Province's land base is included in designated protected sites.

It is the intent of the Provincial government to expand the system of protected areas to 12% of the Province by the year 2000. The Protected Area Strategy is the process the Province is following to achieve this target.

Given the site of the Burnaby Mountain Conservation Area (approximately 800 hectares or about 8% of the City's area), its local and regional significance from a natural heritage, cultural heritage and recreational perspective, staff are proposing that Council authorize the submission of an application for protection of the Burnaby Mountain Conservation Area under the Protected Areas Strategy.

The City Manager recommended:

- 1. THAT Council direct staff to nominate the public land in the Burnaby Mountain Conservation Area (see Figure 1) as a candidate site for protection under the Province's Protected Areas Strategy, subject to detailed delineation of the site boundaries in consultation with the Burnaby-SFU Liaison Committee.
- 2. THAT a copy of this report be forwarded to President John O. Stubbs, Simon Fraser University, Burnaby, B.C., V5A 1S6.
- THAT a copy of this report be forwarded to the GVRD.
