In closing, the nurses advised that they would be available to meet with Council members at any time to discuss their contract dispute.

CARRIED UNANIMOUSLY

a) Ms. Nancy Johnston, Chair, Burnaby Public Library Board and Mr. Paul Whitney, Chief Librarian appeared before Council to present the Burnaby Library's 1993 Annual Report and to thank Council for their continued support.

The speaker outlined highlights from the Annual Report advising that three million items were loaned in 1993. Circulation increased by 8.7%; reference questions asked increased 9.2% and an average of 4,500 people per day visited a library in Burnaby.

Ms. Johnston noted that the Bob Prittie Metrotown Library is the busiest library in the province with respect to circulation. The speaker touched on the challenges facing libraries today including providing services to the multicultural community, the implementation of Interlink Services and the impact of the Information Super Highway.

The speaker concluded by expressing appreciation to Councillor Doug Evans for his contribution as Council's representative on the Library Board and noted that the 1994 Library Board members are looking forward to a busy and challenging year.

b) Mr. Malcolm Johnston, Chair, Metropolitan Transit Association and member Light Rail Transit Association appeared before Council to present information in support of Light Rail Transit.

Councillor Redman entered the Council Chamber at 7:30 p.m. and took her place at the Council table.

Mr. Johnston defined "Light Rail Transit" as a mode of transport which can deal economically with anywhere from 2 to 20,000 riders in any given direction. It is usually a steel wheeled vehicle which is electrically powered by overhead lines and can operate at street level or on a rail line. LRT is heavier and carries more passengers than buses.

The speaker presented a review of a variety of locations currently utilizing LRT systems in the Far East, Europe and the United States. Mr. Johnston presented information on construction costs and a comparison between LRT and SkyTrain which he described as an outdated mode of transportation.

Mr. Johnston concluded by reiterating the value of LRT as a solution to the Lower Mainland's transit problems.

c) Mr. Des Turner, 4577 Brentlawn Drive, Burnaby, B.C. appeared before Council to discuss transit issues in the Lower Mainland.

It is Mr. Turner's contention that factors affecting transit in Burnaby include a pro-automobile bias; increased traffic arising from increased development; and the existence of a variety of traffic "choke points" throughout the Lower Mainland (i.e.: bridges, tunnels, etc.). Air Quality Management is also of concern, especially as 75% of Lower Mainland air pollution comes from the automobile. Burnaby's geographical location contributes to ongoing transportation problems as the outlying areas develop. Given these concerns, Mr. Turner feels that the only viable option is Light Rail Transit.

The speaker concluded by expressing support for Council's position in opposing the densification required in Transport 2021 Plans unless an LRT line is constructed first.

d) Mr. Harvey Elder, President, East Burnaby Ratepayer's Association appeared before Council to present a proposal for improved transit services. The Association is proposing a new bus route which would travel from the Edmonds SkyTrain Station along Edmonds to Sixth Street; from Sixth to Sixteenth Avenue; from Sixteenth Avenue to Cariboo; from Cariboo to Gaglardi Way and from Gaglardi Way to SFU.

Mr. Elder then listed the following advantages to the proposal; a comparable travel time to the #145 bus route from Scott Road Station; a less congested route to SFU; will provide a connection to the Cariboo Park and Ride; provide a connection between East Burnaby and the Edmonds Area including access to the Eastburn Community Centre; and would reduce commuter traffic through Burnaby neighbourhoods.

Councillor Drummond retired from the Council Chamber at 8:01 p.m.

e) Mr. Wally Kloeble, 6473 Gordon Avenue, Burnaby appeared before Council to discuss the need in Burnaby for "adult oriented housing".

Councillor Rankin retired from the Council Chamber at 8:05 p.m.

Councillor Corrigan retired from the Council Chamber at 8:05 p.m.

Mr. Kloeble expressed concerns that placing undue restrictions on properties limits their sales value and will place a future burden on taxpayers when the maximum value of land is not realized.

Councillor Rankin returned to the Council Chamber at 8:06 p.m. and took his place at the Council table.

Mr. Kloeble discussed the advantages to adult oriented housing and read the text of a petition containing seventy signatures which states as follows:

"We the undersigned support the provision of adult oriented housing which provides a quiet environment for those who want to associate with others of common ages and interests. We urge City Council to refrain from enacting restrictive zoning bylaws which restrict such developments."

The speaker concluded by requesting Council not place restrictions on lands which would effectively prohibit the provision of adult oriented housing.

Councillor Drummond returned to the Council Chamber at 8:10 p.m. and took his place at the Council table.

Councillor Lawson requested staff investigate the proportion of Burnaby residents who are single occupants and/or fall within the 45 to 65 age group.

Councillors Evans, Redman and Young retired from the Council Chamber at 8:20 p.m.

 Inclusion of Mitigation Measures in Provincial Highway Improvements in Urban Areas.

WHEREAS the improvement of the provincial highways system in the Lower Mainland will necessitate special provisions for developing highways in urban areas, such as noise mitigation measures, screening, fencing and other off-road improvements, and;

WHEREAS the Highways Act and pursuant guidelines for cost sharing allocate these costs to the affected municipality which creates an inconsistent standard of provincial highway development amongst municipalities;

THEREFORE BE IT RESOLVED THAT the Province be requested to amend the legislation and guidelines governing the development of the provincial highway system in the Lower Mainland to allow for the provincial funding of special off-road mitigation measures considered necessary in urban areas.

2. Mandatory Licence Suspension for Possession of a Stolen Motor Vehicle.

WHEREAS motor vehicle theft and possession of stolen motor vehicles by teenagers is a serious problem in British Columbia;

AND WHEREAS often the offenders are new drivers or too young to obtain a licence:

AND WHEREAS the loss of driving privileges would be a significant deterrent to young people who are considering involvement in these offences;

THEREFORE BE IT RESOLVED THAT the Provincial government be requested to take the necessary steps to include mandatory drivers licence prohibition or mandatory prohibition for a specified period on the right to obtain a licence as a penalty for theft of a motor vehicle or possession of a stolen motor vehicle.

The Heritage Advisory Committee submitted a report requesting Council's concurrence with the first phase implementation plan outlined in the Burnaby Heritage Strategy Report.
