PURPOSE:

To obtain approval to award a contract for machine laid asphalt

and asphalt grinding.

## **RECOMMENDATION:**

1. THAT a contract be awarded to the lowest bidder, Jack Cewe Ltd., for the supply and installation of machine laid asphaltic concrete and asphaltic concrete grinding throughout Burnaby for a total cost of \$1,442,186.10 with final payment based on actual quantities and unit prices tendered.

## **REPORT**

Five tenders for this contract were received by the closing time of 3:00 p.m., Tuesday, 1994 June 07, and were opened by staff in the presence of representatives of the firms bidding. A tabulation of the tenders received is <u>attached</u> (Attachment A).

The work of this contract involves the supply of all labour, materials, tools, plant and equipment required for the grinding of approximately 60,000 square metres of existing asphalt, the laying of approximately 19,000 Tonnes of asphalt and other miscellaneous work on various roads throughout Burnaby.

The Director Engineering's estimate for this work is \$1,555,000.00.

The recommended bidder, Jack Cewe Ltd., has been in business in the Lower Mainland for approximately 38 years. Jack Cewe Ltd. has performed the work of numerous local improvement and roadwork contracts for the City including, most recently, Contracts Nos. 9211 and 9313. Both contracts were for machine laid asphalt and asphalt grinding. Based on their past performance, the Director Engineering is satisfied that they have the experience and resources to complete the work of this contract.

The funding for this project is included in the 1994-1998 Capital Budget under 1994 Street and Lane Rehabilitation. Elsewhere on the agenda is a report from the Director Engineering seeking approval of Work Order No. 60-08034 to authorize the expenditure of the funds.

The Director Engineering concurs with the above-recommendation.
