CONSTRUCTION OF SUSSEX CREEK REPLACEMENT CULVERTS

PURPOSE:

To obtain approval to award a contract for construction of

replacement culverts of Sussex Creek.

RECOMMENDATION:

1. THAT a contract be awarded to the lowest bidder, P. Baratta Construction Ltd., for the construction of replacement culverts of Sussex Creek, for a total cost of \$220,544.23 with final payment based on actual quantities and unit prices tendered.

REPORT

Six tenders for this contract were received by the closing time of 3:00 p.m., Tuesday, 1994 May 31, and were opened by staff in the presence of representatives of the firms bidding. A tabulation of the tenders received is attached (Attachment A).

The work of this contract involves the supply of all labour, materials and equipment required for the construction of replacement culverts of Sussex Creek.

The Director Engineering's estimate for this work is \$173,300.00. The difference between the Engineer's estimate and the lowest tender is due to the high degree of risk associated with the presence of corduroy under the railway line.

The recommended bidder, P. Baratta Construction Ltd., has satisfactorily completed construction contracts for the City in the past and has the necessary equipment and personnel to complete the required work. Based on their past performance, the Director Engineering is satisfied that they have the experience and resources to complete the work of this contract.

The funding for this project is included in the 1994-1998 Capital Budget under 1994 Storm Sewer Extensions. Elsewhere on the agenda is a report from the Director Engineering seeking approval of Work Order No. 60-32095 to authorize the expenditure of the funds.

The Director Engineering and our consultant, Kerr Wood Leidal Associates Ltd., concur with the above recommendation.
