a) Mr. Mark Angelo, B.C.I.T., Fish, Wildlife and Recreation Program, appeared before Council to discuss the Burnaby Lake System Project.

Mr. Angelo introduced Mr. Bob Gunn, Project Coordinator and provided Council with details of the proposal.

During the past four years B.C.I.T. has been working with the City and the G.V.R.D. to conduct a biophysical inventory and assessment on the Burnaby Lake system. As a result of the experience gained through this work, B.C.I.T. is now proposing to initiate a community fund-raising program which would focus on projects to protect and enhance this system. It is their goal to raise \$250,000 over the next three years to fund fisheries enhancement work, wildlife enhancement projects and public education projects. A number of projects are scheduled to commence in 1994 including culvert construction; work on barriers on the lower part of Deer Creek; the establishment of spawning beds on the upper part of Deer Creek; production of a brochure; production of a video on watershed enhancement; development of an interactive video disk for CD ROM for use by school groups and creation of a mural to commemorate Rivers Day.

Mr. Angelo requested Council commit to a financial contribution of \$10,000 in each of the next three years as the City's contribution to the project.

Councillor Drummond entered the Council Chamber at 7:10 p.m. and took his place at the Council table.

B.C.I.T. has committed to fund all salaries related to the project including the Project Co-ordinator and summer students. The speaker noted some advantages to the projects which include increasing public participation in the preservation of the system, the encouragement of a systems approach to managing the watershed, providing funding for valuable projects which would otherwise not receive funding and it is in line with the State of the Environment Report goals of community stewardship.

Water service was activated in 1993 August when the building permit was issued and accordingly the owners were levied partial 1993 utility charges of \$43.79 and full 1994 utility charges of \$292.00 for a single famly dwelling.

Staff are currently reviewing the level of fairness and equity in the flat water rates among housing types in the City. The results of the review will be discussed in the annual water rate setting report in November which will propose water rates for 1995.

Staff have contacted Mr. Aitchison and discussed his concerns. He appreciated our response.

The City Manager submitted a report from the Director Recreation and Cultural Services advising that the Gavel Historical Society has submitted a request to construct at Burnaby Village Museum, and at the Society's cost, a facsimile of a 1914 building that stood at the corner of Boundary and Kingsway and which contained Burnaby's first Masonic Lodge.

The building would be located in a lane, just off the Museum "Village Street". It would be fully owned by the City and would be available for public use including historic living and static displays and approximately 1,500 square feet of prime space for Burnaby's use, approximately 1,500 square feet of second floor space for use by school children or for public rental or programming and basement space for storage and ancillary museum uses.

The City Manager recommended:

- 1. THAT the request of the Gavel Society to build a 1914 Heritage Masonic Lodge Building at Burnaby Village Museum be approved subject to the signing of the requisite agreements.
- THAT the legal agreements to cover the construction and the operation of the building be prepared for Commission and Council approval.

However, the current practice would be to direct all received complaints to the R.C.M.P. for investigation and enforcement. The R.C.M.P. are then in a position to enforce Section 3 of the Burnaby Noise or Sound Abatement Bylaw No. 7332 which prohibits the cause of any noise or sound in or on a highway or elsewhere in the municipality which disturbs the quiet, peace, rest, enjoyment, comfort or convenience of the neighbourhood.

The City Manager recommended:

Identification of Issues
Brentwood Town Centre Review - Phase I

The public consultation process involved the distribution of information brochures, open houses and workshops. As a result of this process many issues were raised and categorized as follows: nature of the Town Centre concept and core development; housing development approach and related issues; concerns about consequences of major redevelopment; protection of existing single family dwelling neighbourhoods and transportation issues.

The information gathered to date and the issues identified through the consultation process will assist in the next phase which is to determine a revised policy framework or vision for the Brentwood Town Centre.

The City Manager recommended:

 THAT staff be authorized to pursue the development of a comprehensive statement of policies and objectives which would take into consideration the issues identified in this report from the public consultation process, on which to base a revised Brentwood Town Centre concept.

The report addresses the concerns raised by Council with respect to the provision of direct public access to the waterfront at specific locations. In order to ensure that the City's position on public access is reflected in the Draft Port 2010 document, staff are recommending that the following be added:

"In the case of new developments or major redevelopments within the designated deep sea terminal areas which abut upland open space areas in Burnaby, measures will be pursued to provide strategic public accesses to the Inlet."

The City Manager recommended:

- THAT the Port of Vancouver be requested to revise the land use designation for the General Chemical Ltd. lands and the adjacent VPC waterlot from Marine Use and Port Services to Port Recreation.

THEREFORE BE IT RESOLVED THAT Burnaby Council requests the G.V.R.D. investigate fencing a portion of the Burns Bog landfill for disposal of airline waste and further investigate deep burying the waste in the Burns Bog landfill and that the G.V.R.D. reach agreement with Canadian Airlines to fully pay for any improvements or expenses as a result of these options."
