a) Mr. Ron Loland, 4195 Cherrywood Crescent, Burnaby, B.C. appeared before Council to discuss a proposal to establish a Regional Soccer Centre in Burnaby which would provide soccer facilities for use by all soccer groups.

Councillors Corrigan and Rankin entered the Council Chamber at 7:06 p.m. and took their places at the Council table.

The soccer centre would incorporate three lighted Olympic size high quality fields, B.C. Soccer Association Offices, a clubhouse, training facilities, dressing rooms and special event facilities.

The Kensington Soccer Society, which is made up of members from a variety of soccer organizations are looking to the City for a long term lease of lands, located adjacent to the Sons of Norway Hall, for development as the Regional Soccer Centre.

Councillor Redman entered the Council Chamber at 7:10 p.m. and took her place at the Council table.

Mr. Dave Fryet, B.C. Soccer Association, attended the podium to explain the reasons behind the Association's support for the proposal. Mr. Fryet noted that B.C.S.A. currently uses office space on Douglas Road which also houses B.C. Youth Soccer, Metro Men's and Women's Leagues, Vancouver 86's and the Canadian Soccer Association, Western Division. All these organizations would be prepared to relocate to the proposed Centre.

Mr. Dave Erhart, 5455 Buckingham, attended the podium to provide more detailed information on the proposal. Mr. Erhart noted that all capital and operating costs would be provided by the Kensington Soccer Society. Use of the facility would free up space at local parks for other uses. Some teams which are prepared to use the proposed facility include the World Cup Team, National Men's Under 20 Team, National Women's Under 20 Team, Pan Am Games Team, B.C. Select Team as well as local soccer teams, with particular emphasis on youth programs. Any available times remaining would be offered to Burnaby for community use.

The speakers concluded by requesting Council's consideration of the lease request.

Arising from the discussion Councillor Corrigan was granted leave to introduce the following motion:

The speaker outlined her situation and the verbally abusive treatment received by employees of Buster's and requested Council's assistance to satisfactorily resolve her concerns.

- c) Mr. Spencer Schrump, President, Buster's Towing appeared before Council to address the concerns of the previous delegation.
 - Mr. Schrump advised that he has not had any problems of this type since he took over the operation in 1987. He advised that he personally interviews and hires his office staff and provides training to assist them in trying to diffuse confrontational situations.
 - Mr. Schrump and his Manager have interviewed the employees involved and they deny the accusations made by Ms. Pagnottaro.

It is the feeling of the speaker that his employees did not conduct themselves in an inappropriate manner and as a result does not feel that there is any necessity to take further action with respect to this situation.

A letter dated 1994 April 05 was received from Linda Anne Gomez expressing concerns about letters to Council becoming public documents. The writer was unaware that by writing to Council her letter would become part of an open Council agenda thereby being released to the media and other members of the general public.

The Committee advises that during 1993 some of the areas of concern and projects undertaken include discussions on violence on television and in movies and the issue of youth violence and its relationship to the Young Offenders Act, review of proposed Federal anti-stalking legislation, review of a proposal to develop a Family Justice Centre in New Westminster and a proposal to develop regulations governing classification of arcade and video games.

 - 1. Employee Assistance Program (E.A.P.)

The City Manager submitted a report from Director Recreation and Cultural Services requesting Council approval for the continued funding of the Employee Assistance Program. The Program is administered by a joint Committee which includes representatives of the City and one representative each from CUPE, IAFF and BCNU. Utilization in 1993 was 100 individual referrals, up from 97 referrals in 1992. Staff advise that the consultants have not increased their fee rate in 1994, however, staff are recommending a slight increase in the budget to cover costs of a client satisfaction survey to be conducted by the consultants and to cover an estimated increase in usage by employees. The recommended budget for 1994 is \$54,575.

The City Manager recommended:

The current system has been in place for 17 years and is now outdated. Staff are recommending the system be replaced with a more versatile and productive geographic information system environment. The cost of this upgrade would be approximately \$288,000 and is included in the 1994 - 1998 Capital Program.

- THAT Council approve the expenditures for hardware, software and consulting services related to the replacement of the mapping system as outlined in this report.

Some of the concerns raised at the Public Hearing include increased noise emanating from traffic on Sperling Avenue and disruption caused by patrons of Lochdale Hall. In response to these concerns it is proposed to increase the fence along the east property line to a height of six feet, constructed of solid wood and with tall shrubs to be planted in the landscape strip inside the fence. A new six foot high solid wood fence would also be built along the south property line and the areas between the sidewalk and the parking stalls would have small increase in grade, with low shrubs planted on the low berm.

Public Hearing Concerns

The City Manager submitted a report from the Director Planning and Building prepared in response to Council's request for information regarding concerns raised at the Public Hearing for Rezoning Reference #61/93 and to seek Council's support for the installation of a traffic signal at Sperling Avenue and Canada Way. The primary concerns raised at the Public Hearing pertained to the traffic signal at Canada Way/Sperling Avenue or Canada Way/Chiselhampton Street and the impact of the proposed development on school capacity in the area.

Discussions with the School District have determined that should Buckingham School exceed its capacity, portable facilities will be used to accommodate the overflow. It is also the view of staff that a traffic signal on Canada Way between Kensington and Burris is necessary to accommodate the rezoning and that Sperling is the preferred location for this signal.
