CARRIED UNANIMOUSLY

a) <u>Deborah Wotherspoon</u>, President of Airspace Non-smokers' Rights Society appeared before Council to provide a personal perspective of the affects of second hand tobacco smoke. Ms. Wotherspoon made reference to a letter recently printed in the Edmonton Journal from Heather McDonald, an individual who had suffered the affects of second hand smoke which eventually took her life.

Councillor Lawson arrived at the Council Meeting at 7:05 p.m. and took her place at the Council table.

Councillor Redman arrived at the Council Meeting at 7:06 p.m. and took her place at the Council table.

Ms. Wotherspoon advised Council that she had collected 4,500 signatures on a petition in support of the initiative to achieve 100% smoke-free indoor environments in public places and stressed the fact that second hand smoke is proven to be a very serious health issue in today's society.

Mr. David March, B.C. Council on Smoking and Health appeared before Council seeking endorsement from all members of Council for a 100% smoke-free environment. Mr. March discussed the health issue in a broad policy concept and suggested the most important initiatives to be taken immediately are a public education process and the establishment of a healthy public policy. Mr. March suggested that positive initiatives would further the care, protection, promotion and preservation of the health of the inhabitants of the City of Burnaby by endorsing a 100% smoke-free indoor environment.

MOVED BY COUNCILLOR LAWSON: SECONDED BY COUNCILLOR DRUMMOND:

"THAT Item 1, Acting City Manager's Report No. 71, 1994 December 19 be brought forward for consideration at this time."

1. 100% Smoke-Free Indoor Environments

The Acting City Manager submitted a report from the Medical Health Officer advising of the Greater Vancouver Metropolitan Health Departments' initiative to achieve 100% smoke-free indoor environments in public places and seeking Council's approval to investigate the ramifications of proceeding with the proposed strategies to achieve this objective. Staff advised that the weight of medical evidence clearly indicates that the public and workers "passively" exposed to tobacco smoke are at increased risk of developing lung cancer and other serious diseases. Sound public health policy would dictate that it is time to phase out smoking indoors as quickly as possible. A total ban on smoking in the workplace and public places is the only policy that would totally protect public health and the health of workers from ETS exposure.

The Acting City Manager recommended:

 THAT the Health Department, in conjunction with other Greater Vancouver Metropolitan Health Departments/Units, carry out a public consultation process through the spring of 1995 in order to investigate the ramifications of achieving 100% smoke-free indoor environments in public places.

MOVED BY COUNCILLOR DRUMMOND: SECONDED BY COUNCILLOR YOUNG:

"THAT the recommendation of the Acting City Manager be adopted."

MOVED BY COUNCILLOR REDMAN: SECONDED BY COUNCILLOR YOUNG:

Dr. Arlene King, Medical Health Officer attended the speaker's podium to respond to questions from Council.

Mr. Ward is of the opinion that access onto Wedgewood Street from this business is a serious error that needs immediate attention as Wedgewood Street is a residential street with only a 20 ft. width. Mr. Ward requested Council to put a hold on the development until such time as a compromise can be achieved to ensure limited access from the business onto Wedgewood Street.

In concluding, Mr. Ervin advised he was not satisfied with several items within the budget and reminded Council that tax increases also effect renters. The speaker suggested that there will come a time that residents will not accept property tax increases and will refuse to pay their property taxes.

A letter dated 1994 November 22 was received from the Surveys Officer, Food Production & Inspection Branch, B.C. Coastal District Office, Agriculture Canada advising that the 1994 Gypsy Moth Program survey had now been completed and that in the Burnaby district two European Gypsy Moths have been found: one near Marine Way and Boundary; the other near Kingsway and Gilley Avenue. Based on these two finds and the wide proximity in which they were found, treatment measures will not be initiated for this area. However, the writer advises that comprehensive monitoring using pheromone traps will recommence in the spring of 1995.

Burnaby Mountain Urban Trail
 Production Way to Cameron Park

The Acting City Manager submitted a report from the Director Recreation and Cultural Services providing information on Burnaby Mountain Urban Trail from Production Way to Cameron Park.

The report recommends the Eastlake Park/Cameron Street Route identified as Option #2. The trail crosses through four parks sites including Eastlake Park, Stoney Creek Ravine Park, Bell Park and Cameron Park. Parks staff agree in principle with the preliminary routing, although site specific details need to be resolved and reported to the Parks and Recreation Commission as they become available. Detail concerns are generally minor in nature and it is felt they can be resolved or rehabilitated during construction. The Eastlake Park/Cameron Street Urban Trail Route offers the potential of an important community park link.

City staff are in agreement with the proposed changes and consider the estimate to be reasonable.

Under normal circumstances, the report covering the contract renewal is presented to Council in December. This year staff received a proposal from the S.P.C.A. that did not meet Burnaby's fiscal or operational needs.

A resubmission is expected when the S.P.C.A. has concluded its negotiations for a collective agreement with its employees. The S.P.C.A. is willing to provide their service as recommended and will work with staff towards an adjusted contract proposal for 1995.

The Acting City Manager recommended:

- THAT the S.P.C.A. continue to provide the services of Poundkeeper in 1995 on a month to month basis, under the terms and conditions of the 1994 contract, providing that the rate to be negotiated for the provision of services in 1995 shall be retroactive to 1995 January 01; and
