PURPOSE:

To seek approval for 1995 lease rates and grants for non-profit tenants at the

Burnaby Heights and Edmonds North Wing community resource centres.

RECOMMENDATIONS:

- 1. THAT the Committee request Council to approve the proposed 1995 lease rates and grants as contained in this report.
- 2. THAT the Committee request Council to authorize staff to make the appropriate lease renewal arrangements with Burnaby Heights and Edmonds North Wing tenants.

REPORT

1.0 INTRODUCTION

In 1992 April, Council approved guidelines for the issuance of grants to offset lease rates to non-profit groups allocated space at community resource centres. In general, tenants at community resource centres can qualify for a grant to offset 25% or 50% of lease costs depending on the level of service provided to Burnaby residents.

At its meeting of 1994 November 15, the Executive Committee - Grants approved in principle 1995 lease rates and grants for tenants at the Burnaby Heights and Edmonds North Wing community resource centres. The Committee also directed that the report outlining the proposed 1995 lease rates and grants be distributed to tenants for review and comment.

Based on the lease grant guidelines and the information received from tenants, this report proposes 1995 lease rates and grants for tenants of the Burnaby Heights and Edmonds North Wing community resource centres.

2.0 PROPOSED 1995 LEASE RATE

In 1991, Council established a market value lease rate for community resource centres that was to be adjusted annually for inflation. For 1994, the lease rate was set at \$8.77/sq.ft. per annum for office space and \$5.43/sq.ft. per annum for workshop/utility space.

Staff are proposing that the lease rates for 1995 be increased by 2.0%, in line with the general rate of inflation during the last year. This would result in 1995 lease rates of \$8.94/sq.ft. per annum for office space and \$5.54/sq.ft. per annum for workshop/utility space.

In accordance with Council policy, the lease rate for the Burnaby School District is proposed to increase by 4% above the general rate of inflation until it reaches the established market level.

Appendix 1 attached, Table 1 shows the proposed lease rates for 1995 for each tenant.

3.0 PROPOSED 1995 LEASE GRANTS

3.1 Review of Applications

In 1994 July, staff requested tenants to make application for 1995 lease grants. Tenants were advised of the anticipated lease rate increase, and provided with a lease grant application form. Requests for lease grants were submitted to staff in 1994 August and September.

All of the requests for lease support were consistent with the lease grant guidelines, with the exception of MADD - Mothers Against Drinking Drivers.

As this point, the MADD office continues to serve as the national, provincial and local office of MADD. The Society has not been able to demonstrate that over 25% of the recipients of its services, programs or activities are Burnaby residents. As such, the organizations does not fulfill the lease grant guidelines for partial lease grant support.

The proposed 1995 lease rates and grants were distributed for review and comment to tenants at the Burnaby Heights and Edmonds North Wing centres. As of the date of this report, only one comment was received from the Voices for Survivors Support Society. The Society advised that it did not apply or received lease support in 1994, and requested that this be noted in the report.

3.2 Proposed Adjustments in Lease Grant Support

Staff are proposing a number of minor adjustments to the level of lease support provided to some Burnaby Heights tenants to ensure that all qualifying tenants receive the same level of lease support. For each tentant, Appendix 1, Table 2 shows the basic level of eligibility for lease support, the level of lease support actually provided in 1994, and the level of lease support proposed for 1995 for each tenant.

Tenants leasing space at the Burnaby Heights facility prior to 1991 qualify for lease grants to hold lease costs at their 1991 lease rates with appropriate adjustments for inflation. When the City acquired the facility from the School District in 1991, the lease rates for tenants in the facility varied considerably. For new tenants, the lease grant guidelines provide for grants to offset 25% or 50% of established lease rates depending on the level of service provided to Burnaby residents.

As a result, the current lease grant program has provided varied levels of lease support for some Bumaby Heights tenants, ranging from a low of 47.3% to a high of 64.1% of established lease rates. In most cases, this reflects differences in lease rates between tenants prior to 1991 when the City acquired the facility.

Staff are proposing that the levels of lease support be adjusted, over time, to provide the same level of lease support for all tenants in relation to the basic lease grant guidelines (lease grants equal to 25% or 50% of lease costs depending on the level of service provided to Burnaby residents).

Staff are proposing to increase lease grant support to 50% for those tenants who qualify for full support but are receiving less. These tenants include: Burnaby Multicultural Society (47.3%), Burnaby Seniors Peer Counselling (46.6%), Burnaby/ New Westminster Child Support Program (49.4%), and Comitato Attivita Scholastiche Italiane (47.2%).

In addition, staff are proposing to reduce the level of lease support by 2 percentage points, each year, for those tenants that qualify for full support but are receiving more. These tenants include: Boy Scouts of Canada (55.4%), Burnaby Information and Community Services Society (64.1%), and the Burnaby Volunteer Centre (60.7%).

Two tenants, the Burnaby Association for the Mentally Handicapped (50.1%) and the Burnaby Family Life Institute (51.1%) received slightly more that the 50% provided by the lease grant guidelines. This is largely due to rounding errors over the past three years of the lease grant program. Staff would also propose to adjust these lease grants to 50% of established lease rates.

The proposed adjustments will have a relatively small effect on the annual lease costs for these tenants. Appendix 1, Table 4 shows the proposed lease rate increases after the issuance of the proposed lease grants.

4.0 NEXT STEPS

It is proposed that the Committee forward this report and recommendations to Council for approval of the proposed 1995 lease rates and grants.

It is also proposed that staff be authorized to make the necessary 1995 lease renewal arrangements with tenants of both centres. Once approved by Council, the Finance Department would adjust the monthly lease charges of the benefiting organizations to reflect the approved grant amount. The grant funds would be transferred internally for budgeting and accounting purposes.

Any further applications for lease support received by staff will be brought forward for the consideration of the Committee as necessary.
