- a) Mr. Mark Fletcher, 1573 - 101 Avenue, Surrey, appeared before Council on behalf of Burnaby Firefighters requesting the City co-fund with the Burnaby Firefighters Charitable Society, the purchase of 12 Defibrillators to equip all of Burnaby's first line emergency response vehicles.

Mr. Fletcher advised that timing is of critical importance in preventing brain damage or death in victims of cardiac arrest. Defibrillation is an important part of early treatment, however, Burnaby Firefighters do not currently have the equipment necessary to administer this treatment.

The speaker noted that the appropriate Defibrillation treatment will save lives and be of critical importance in providing first response emergency treatment.

The proposed equipment is manufactured by Space Lab and is state of the art, upgradeable equipment which is compatible with other fire departments as well as the Provincial ambulance service. Mr. Fletcher presented a price quotation from the Space Lab Company for a total of \$71,083.

Arising from the discussion Councillor Young was granted leave to introduce the following motion:

Ms. Gordon recognized the contribution of the late Tom Constable, a former Mayor of Burnaby and a member of the Burnaby Mountain Preservation Society toward the preservation of this valuable natural resource.

The speaker noted that the B.M.P.S. supports Council's application to have these lands included in the Protected Area Strategy.

Ms. Diane Hansen also addressed Council reiterating support for the preservation of the Burnaby Mountain Conservation Lands and its inclusion in the Protected Area Strategy.

The Traffic and Transportation Committee (Transportation and Transit Division) submitted a report prepared in response to a B.C. Transit report regarding Rapid Bus Service. The transit report notes that two routes have been identified for implementation in the 1994/1995 budget year; the Richmond - Vancouver route and the Lougheed - Broadway route. However, the report appears to grant priority to the Richmond - Vancouver route with implementation scheduled for 1994 and implementation of the Lougheed - Broadway route in 1994/95.

As a result, the Committee is requesting Council write to B.C. Transit requesting clarification as to when the Lougheed - Broadway Rapid Bus Service will be implemented.

The Traffic and Transportation Committee (Transportation and Transit Division) submitted a report outlining an approach for the development for the Community Transportation Plan and to address concerns of south east Burnaby residents regarding traffic patterns in their area. Commuter traffic is using residential streets in the area to avoid congestion along 16th Avenue and 10th Avenue.

In order to expedite the process the Committee is recommending a survey be sent to all residents in the area and a Resident Committee be formed to meet in the fall.
