**R E P O R T**

**1.0 BACKGROUND**

Appearing on the agenda of the regular meeting of the Traffic and Transportation Committee on 1994 May 30, were several letters from residents of south east Burnaby. These residents, of 18th Avenue and 4th Street, expressed concerns regarding the speed and volume of traffic on their residential streets. Staff have also had several telephone calls from area residents with similar concerns.

In order to address the traffic problems of the whole area, staff propose that the Community Transportation Plan be developed, as indicated in the draft Burnaby Transportation Plan. This report outlines an approach for the development of the Community Transportation Plan.

**2.0 Resident Input**

The attached survey should be sent to all households in the area outlined in Figure 1. The survey asks for some feedback regarding any traffic related concerns, as well as the importance of access into and out of the area. The residents are also asked if they would be willing to be part of a Resident Committee to work with staff to develop a Community Transportation Plan for their area.



Once a Resident Committee has been formed, it will meet with staff to develop methods of discouraging traffic infiltration. It is expected that the first meeting will be held in 1994 October. Once a Community Transportation Plan has been endorsed by the Resident Committee, there will be a survey of all households in the study area to assess the level of support. At the same time, a public open house will be held to allow area residents to ask questions of both staff and the Resident Committee regarding the Community Transportation Plan.

### 3.0 CONCLUSION

Several residents of south east Burnaby have contacted staff to express their concerns regarding traffic patterns in their area. Commuter traffic is using residential streets in the area to avoid congestion along 16th Avenue and 10th Avenue.

The Burnaby Transportation Plan (draft) identifies the area of south east Burnaby as an area in which there will be "Neighbourhood Protection Actions", ie. a Community Transportation Plan to discourage traffic infiltration. Residents of the area have come forward to ask that the City expedite the Community Transportation Planning process. Therefore, staff recommend that a copy of the attached survey be forwarded to all residents in the area, and that a Resident Committee be formed to meet in the Fall.

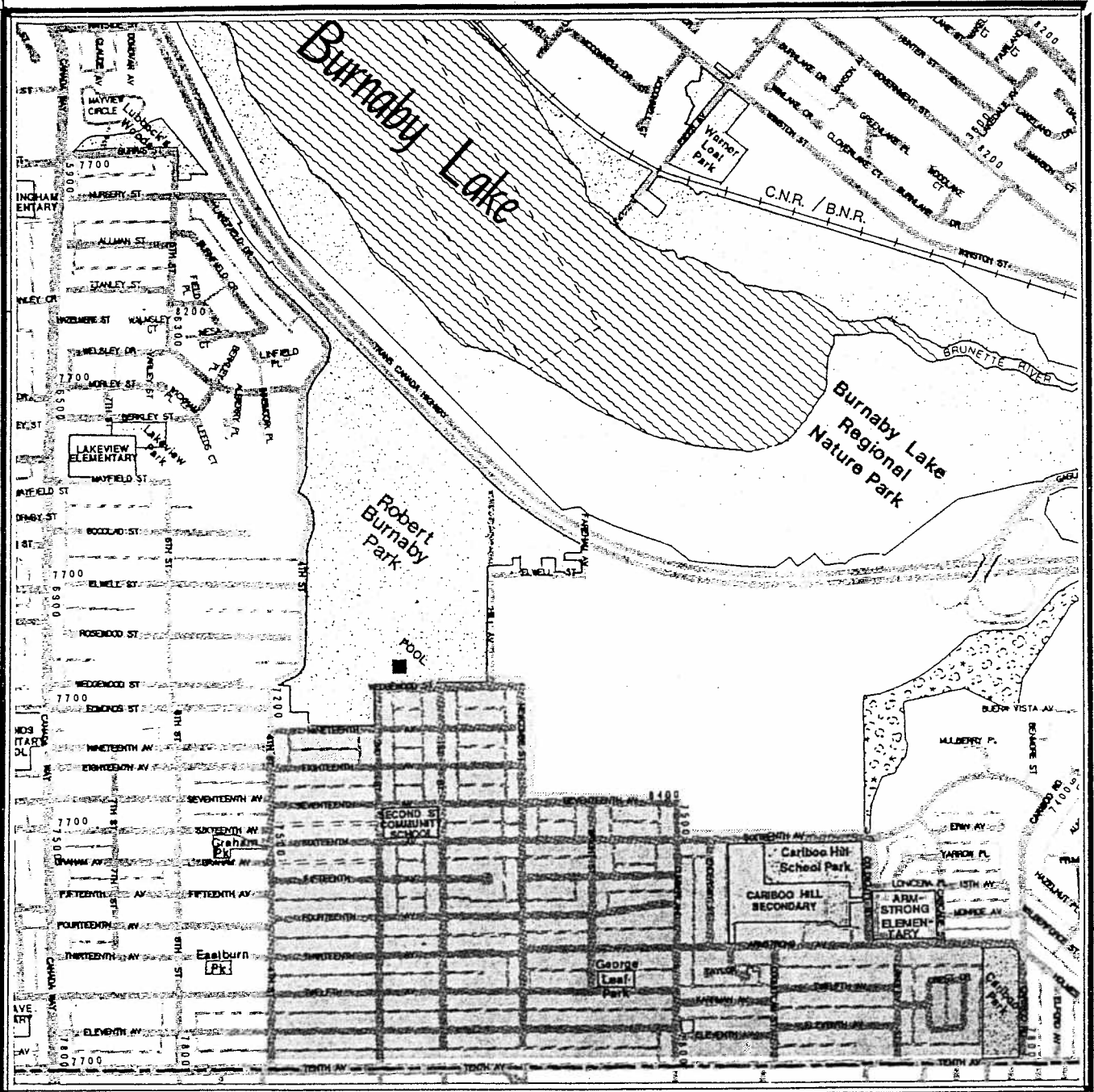
