CARRIED UNANIMOUSLY

a) Mr. Bob Moulds, Chairman, Board of Trustees and Mr. Mark Pelletier, Vice-President, Operations, Burnaby Hospital appeared before Council to enhance Council's awareness of issues facing the hospital, focusing on the strengths, challenges and opportunities facing health care in Burnaby today.

Mr. Moulds advised that Burnaby Hospital has served this community and east Vancouver residents for over 40 years. During that time the Hospital has seen several large expansions, most recently in the food services area. Burnaby General will be providing food services to Lions Gate Hospital as well as its own patients.

The speaker noted that Burnaby General is one of the largest acute care hospitals in the Province with an annual budget of \$75 million. The hospital serves approximately 150 patients per day in the Emergency Department and has the lowest Caesarean section rate and infant mortality rate in the Province.

Mr. Moulds complimented Burnaby General's strong volunteer contingent who provide a variety of valuable services to hospital patients.

Mr. Mark Pelletier then provided a brief overview of challenges facing Burnaby General. The speaker noted that the largest challenge is dealing with ongoing budget cuts from the Ministry of Health. Salaries consume more than 80% of the hospital budget and with shrinking revenues, prioritizing services becomes a genuine challenge. Additionally, the hospital is looking at various ways and means to link with other community services to provide better patient care. It is the feeling of those at Burnaby General that the concept of regionalization provides an opportunity to strengthen the continuum of care and enhance the quality of working life within the hospital community.

In conclusion, the speakers thanked Council for the opportunity to appear before them and discuss the challenges facing Burnaby General Hospital.

b) Ms. June Humphrey, 5960 Herbert Road, Richmond, B.C. appeared before Council to discuss the cat population problem in the Lower Mainland. The speaker advised that a variety of community groups raised about \$300,000 per year for cat rescue operations. There are currently about 2,000 cats being looked after by volunteers.

Ms. Humphrey noted that while the number of cats euthanised dropped in Burnaby from 1985 to 1992, numbers are again on the rise. This indicates the number of cat colonies are increasing and the costs of controlling these colonies have become prohibitive.

The speaker noted that the problem is growing while money and other resources are dwindling. As a result, the speaker is requesting Council enact a mandatory spaying and neutering bylaw to control the cat population.

c) Ms. Linda Meade, 4066 McGill Street, Burnaby appeared before Council as an independent cat trapper who works throughout the Lower Mainland trapping stray cats for spaying and neutering.

The speaker advised that at one time these stray cats were pets who have been turned out and eventually a cat colony is formed. The cat colonies are growing at a rapid rate and it is the speaker's feeling that mandatory spaying and neutering is the most effective means of controlling the problem.

Ms. Meade reviewed the problems associated with the rampant growth of the cat population and concluded by requesting Council consider licensing cats and enacting a mandatory spaying/neutering bylaw.

Ms. Sairam stated that people must become more compassionate and caring towards stray cats in order to put an end to their mass euthanasia.

Mr. Knowles appeared before Council to discuss solutions to the cat overpopulation problem. He feels that education by itself is not sufficient to control the cat overpopulation problem, but that education needs to be supplemented through the support of legislation requiring licensing and the mandatory spaying/neutering of cats.

Councillor Corrigan returned to the Council Chamber at 8:13 p.m. and took his place at the Council table.

The speaker then referred to a petition containing 4,000 signatures collected throughout the Lower Mainland requesting enactment of a spay and neuter bylaw. He also distributed information to Council on American spay and neuter laws.

Board regarding planning and development of group homes in the region, commitment of the Province to establish protocols for group home planning and development in B.C. and initiation of the South Burnaby group home review.

As a result of these activities, the Community Issues and Social Planning Committee believes that it would be timely to initiate amendments to the group home provisions contained in the Zoning Bylaw.

Hastings Street Area and Metrotown

The City Manager submitted a report from the Director Planning and Building prepared in response to Council's request for a review of payments in lieu of required parking within the Hastings Street Area in Metrotown.

Use of payment-in-lieu of the provision of parking facilities allows developers to optimize the development potential of small sites which would not be able to accommodate on-site surface parking. It is felt that the provision of public parking will ensure the economic viability and revitalization of the Hastings Street commercial area. As a result, it is felt an established rate of \$8,000 per stall in the Hastings Street area and \$10,000 per stall in the Metrotown area is a reasonable level which should accommodate future development in these neighbourhoods.

The City Manager recommended:

- 1. THAT payment by developers be permitted in the amount of \$8,000 for each stall reduced from the standard commercial parking requirement in the Hastings Street Area Plan.
- THAT payment by developers be permitted in the amount of \$10,000 for each stall reduced from the standard commercial parking requirement for the Metrotown payments-in-lieu program.
