MOVED BY COUNCILLOR EVANS: SECONDED BY COUNCILLOR JOHNSTON:

"THAT the delegations be heard."

a) Mrs. Gerd Evans, 6541 - 12th Avenue, Burnaby, B.C. appeared before Council to request removal of a covenant from their land title which requires removal of a suite in their principle residence when family members no longer require its use.

The speaker contends that they have spent monies on annual fees and water rates for the suite, and have always compiled with City bylaws and should be permitted to retain the suite without a covenant. Mrs. Evans also objects to paying a fee for removal of the covenant as it was placed on their title at the request of the City.

A staff notation appended to the delegate's correspondence advises that staff have met with Mrs. Evans and have discussed various options which would enable the covenant currently registered in the Land Titles Office to be removed. Staff will continue to assist Mrs. Evans and will prepare a report at a later date, should Council so direct.

Arising from the discussion, Councillor Evans was granted leave to introduce the following motion:

"THAT the delegation's concerns be REFERRED to the Housing Committee for review."

b) Mr. Richard Wu, 6380 6th Street, Burnaby, B.C. appeared before Council to discuss traffic problems in the area of Lakefield, 6th Street, and Reigate.

Mr. Wu cites problems with high volumes of traffic; excessive speed; failure to obey traffic signs; pollution and noise as reasons for his support for a proposed closure of 4th Street at Reigate as a way to alleviate some of these problems.

The speaker requested that the residents of Lakefield Subdivision be given due consideration of Council and that the Traffic and Transportation Committee proceed with its survey to determine the most appropriate means to resolve the traffic problems.

Mrs. Wu attended the podium to request Council take into consideration the quality of life of Lakefield residents in considering the proposed traffic pattern changes.

c) Mrs. Ann Saie, 7920 Nursery Street, Burnaby, B.C. appeared before Council to discuss the need to close off the hill past Religate. Mrs. Sale advised Council that a two minute traffic count on Friday, February 04 showed 27 cars passing her house.

The speaker advised that she is a long-time resident of the neighbourhood and that it use to be a quiet peaceful area but that short-cutting traffic is ruining the neighbourhood environment. Mrs. Sale does not feel it is appropriate that one area of Burnaby should negatively affect another area of Burnaby for the sake of a few traffic short cuts.

d) Mr. Harvey Elder, President, East Burnaby Ratepayers Association, appeared before Council to oppose the closure of 4th Street. The Association feels that the proposal should have been part of a wider area plan and should not be dealt with in isolation.

Councillor Drummond retired from the meeting at 7:40 p.m.

Mr. Elder feels that commuter traffic causes problems for all neighbourhoods and as a result should be dealt with on a broad basis and not on an individual neighbourhood basis. Mr. Elder feels the commuter problems and solutions should be shared by all neighbourhoods concerned.

Councillor Corrigan retired from the Council Chamber at 7:50 p.m.

e) Mr. David Brabyn, 6470 Berkley Place, Burnaby, B.C. appeared before Council to express opposition to closure of Lakeview/4th Street.

Mr. Brabyn stated that he specifically purchased his home because of the ease of commute to Royal Columbian Hospital. The proposed closure would lengthen his commute and therefore make it impossible for him to continue to live in the neighbourhood.

Councillor Corrigan returned to the Council Chamber at 8:01 p.m. and took his place at the Council table.

The speaker contends that the traffic volumes are not as high as previously intimated and that many other residents also opposed the proposed closures.

f) Marilyn and Peter Milne, 8190 Lakefield Drive, Burnaby, B.C. appeared before Council to discuss traffic volumes travelling through the Lakefield Subdivision.

The speakers contend that traffic has steadily worsened to the point where they feel they will no longer be able to continue to live in the area because of the negative impact of the traffic.

Mrs. Milne expressed concerns about safety for their children, their ability to enjoy the neighbourhood and their quality of life as reasons for supporting the closure.

Tabled Matter, Item 5 (a) was brought forward for consideration at this time.

Once Council approval of the recommendations is obtained, the Committee will contact area residents to determine the level of support for the proposed changes. The Committee will provide Council with a further report once the views of area residents have been obtained.

 vehicular traffic.
- 3. THAT a copy of the attached questionnaire be forwarded to all residents of the area indicated in Figure 4 to solicit their views on recommendations 1 and 2.
- 4. THAT a copy of this report be forwarded to the R.C.M.P., Fire Department and the B.C. Ambulance Authority, after approval of recommendations 1 and 2.

More than 13% of Burnaby's homeowners are not eligible for a full grant in 1994, up from 6% in 1993. Within the G.V.R.D., over 14% of the homeowners are no longer eligible for full grants, where just over 1% are impacted outside the G.V.R.D.

As a result, staff are suggesting that until a review of Homeowner Grant policy is carried out at the Provincial level, Council support a reduction in grants based on the highest 10% assessed value homes in each regional district. It is felt that this proposal would distribute the tax burden throughout the Province in a more fair and equitable manner.

The City Manager recommended:

- 1. THAT Council express strong opposition to the Minister of Finance on the current Home Owner Grant policy of removing grants on homes valued over \$400,000; and
- 2. THAT Council request the Minister of Finance carry out a review of the Home Owner Grant policy in order to ensure that homeowners in Burnaby and throughout the G.V.R.D. are treated fairly and equitably relative to homeowners in other areas of the Province; and
