Reference to its possible application in the Oaklands development is made in the Committee's report concerning the progress of non-profit housing at Oaklands appearing elsewhere in this agenda. As a point of clarification, the "expressions of interest" will be accepted up to September 12, 1994, rather than the September 04 date referenced in the letter. The Greater Vancouver Housing Corporation (GVHC) is attempting to obtain a listing of available City lands that may be potential sites for future initiatives by GVHC.

Overall, the Minister advises that the Forest Land Reserve Act sets out an effective framework for participation of local government in decisions about converting forest lands for settlement and related purposes.

q) Waste Reduction Commission, 1994 July 20,

Re: Collection of waste paint

A letter dated 1994 July 20 was received from the Waste Reduction Commissioner, Soils and Hazardous Waste providing a copy of British Columbia's and Canada's first industry stewardship regulation for the collection of waste paint. The new paint regulation announced by the Minister of Environment, Lands and Parks takes effect September 01, 1994 and is designed to shift the burden of responsibility from the taxpayer to those who produce paint products, following the 'polluter pay' principles. The new regulation requires that industry have 10 used paint collection centres in the G.V.R.D., 5 in the Capital Regional District and one for each of the remaining 28 regional districts by the September deadline. It is estimated that this new paint collection program will save the province approximately one and a half million dollars per year and the commission therefore hopes that Council will work closely with the industry to ensure that appropriate zoning and bylaws are initiated to enable the success of this new paint collection program.

A staff notation appended to this item of correspondence advises that municipalities in the Lower Mainland are represented by the G.V.R.D. on the committee responsible for the development of the new paint regulation. Staff will continue to provide input through the G.V.R.D. on implementation of the regulation and siting of the collection centres.

The development of a future rapid transit strategy is a major issue facing both the Province and local governments and therefore the Transportation Financing Authority, which has been given responsibility for coordinating provincial transportation, system planning and development, and BC Transit are planning to undertake a more detailed review of the three rapid transit lines identified in Transport 2021. This work will examine the feasibility of the routes including an assessment of the technologies available, ridership and cost projections and will also examine the land use strategies required to justify ICTS systems. Finally, the work will examine how an enhanced bus system could be developed in each corridor as an interim step towards full ICTS application. BC Transit staff and their consultants will be contacting municipal staffs in the near future to request information vital to the work being undertaken.

Certification could be provided by a qualified testing agency or professional that has experience and knowledge of the product, such as required for commercial projects. Policing by the industry would provide sufficient reason to require such certification on specific projects.
