PURPOSE:

To obtain the Executive Committee's support for the payment of the

City's portion of the Burnaby Community Schools Budget.

#### RECOMMENDATIONS:

1. THAT with Council's concurrence \$261,327 be paid to the Burnaby School Board as the City's contribution to the Community Schools for 1995/96.

2. THAT the 1995 Annual budget be adjusted to reflect the above expenditure.

#### **REPORT**

Attached is a copy of the Burnaby School Board's request for Community School funding for the 1995/96 school year. The funding requested by the School Board is \$261,327, an increase of \$61,052 over last year's funding. This is the first increase since 1993 and is mainly due to the funding requested for an additional Community School designation at Edmonds Elementary.

With the authorization of the Executive Committee and Council to pay the requested amount, staff will investigate additional funding sources and means to cover the increased cost of the Community School budget.

# RE: 1995/96 BUDGET FOR COMMUNITY SCHOOLS

The minutes of the 1995-01-26 District Community School Advisory and Coordinating Committee (DCSACC) are attached. The DCSACC serves as a broad based advisory committee to the school district and city on the operations and matters relating to Burnaby's community school program. One of the core responsibilities of the DCSACC is to develop the yearly operating budget for the district's community school operations. Another primary function of the DCSACC is to receive community school designation requests from community residents and schools and make recommendations to the school board and city regarding designation status and funding.

The attached minutes include several recommendations regarding the above. These include:

- (1) THAT, effective 1995-07-01, Edmonds Elementary School be designated a 'community school' and receive a community education funding allocation.
- (2) THAT the proposed 1995-1996 community school budget be approved and that the Burnaby School Board and the City of Burnaby each be requested to provide \$261,327 in their budgets for the support and operation of community schools during the 1995-1996 school year.
- (3) THAT Community School Management Team look at other areas of Burnaby where community schools might be needed.

At its 1995-03-14 meeting the school board approved the designation of Edmonds as a community school and the inclusion of \$261,327 in the Board's 1995/96 preliminary budget as the school's district's share of the community school operations for 1995/96.

#### 1. Agenda

The selection of a Chairperson for 1995 was added to the agenda.

2. Minutes of the 1994.12.08 Meeting

**MOTION** - Begin/Smith - **THAT** the minutes of the 1994.12.08 meeting be adopted as circulated.

## 3. Facilities Update

Staff provided an update on the expansion of school facilities in the various community schools:

Stoney Creek - the construction of a 7-room addition should be put out to tender in February

Stride - the renovation of two classrooms should be put out to tender in February

Lochdale - the addition of six classrooms is now complete. Two of the six portables on site will remain--one for instruction and one for joint school/community use.

#### 4. Meeting of Community School Council Chairpersons

The Gilmore Community Council has offered to initiate the meeting of the five Community School Council Chairpersons.

#### 5. Correspondence

(a) Canadian Association for Community Education

The initial announcement of the 1995 CACE Conference to be held in Vancouver in May was distributed.

It was announced that ACEbc will be offering registrations at a reduced cost for 'community volunteers' from member organizations.

## 6. Information and Emergent Issues

(a) Lochdale Community School

Francisco Salinas reported that the six new classrooms were officially opened last week.

The distribution of the Community Survey has begun. Focus groups have been organized in Korean and Chinese. it is expected that the collection of the returns will be completed by February 6.

# (b) Stoney Creek

Sandy Dunn provided updates on the Friday evening teen program and the community garden project. An average of forty teens is attending the Friday evening program. They are now showing some interest in developing specific programs as opposed to just 'hanging out'. A volunteer community committee is developing a curriculum based on the community garden. This March - June program will culminate with a 'salad feast' in June. Composting and birdhouses have also been added to the community garden project.

# 7. Expansion of the Community School Program

The committee continued its discussion from the 1994.12.08 meeting regarding expansion of the community school program.

Elliott Grieve described the guiding principles which are the foundations of the Community School Program in Burnaby. He also presented an overview of the complex societal issues facing and affecting children,

families and neighbourhoods in the 1990's and how the guiding principles of community education can be used to create a model to effectively respond to these issues.

He presented a schematic suggesting two "community education service delivery models". The first 'community school model' is based on the current approach where a neighbourhood school working in partnership with parents and community residents delivers programs and services which respond to the child as part of a family and the family as part of a neighbourhood and the neighbourhood as part of a larger community.

The second model, also based in a neighbourhood school, sees the school facility as a 'Neighbourhood Education Centre' that functions as a neighbourhood support centre for the development of a sustainable, healthy community in which all can live, learn, work and play. This model establishes a framework for residents to help shape and influence neighbourhood services and programs.

(a) MOTION - Begin/Stables - THAT the community school designation process be expanded to accommodate both 'community education service delivery models'.

#### CARRIED

(b) Designation of Edmonds Elementary School

The Edmonds community has been identified by a number of human services agencies as a neighbourhood which could benefit from a neighbourhood education centre and integrated services approach.

MOTION - Begin/Smith - THAT effective 1995.07.01, Edmonds Elementary School be designated a 'community school' and receive a community education funding allocation.

#### CARRIED

(c) 1995/1996 Community School Budget

Elliott Grieve presented the proposed 1995/1996 budget.

MOTION - Smith/Begin - THAT the proposed 1995-1996 Community School budget be approved and that the Burnaby School Board and the City of Burnaby each be requested to provide \$261,327 in their budgets for the support and operation of Community Schools during the 1995/1996 school year.

#### CARRIED

It was suggested that development of the 1996/1997 budget commence in November in order to include discussions on budget implications with the City early in their budget deliberations.

# (d) Geographic Distribution of Community Schools

Committee members noted that there is a geographic imbalance in where the current designated community schools are located. There are no 'community schools' located in West Burnaby, Central Burnaby and on the South Slope.

**MOTION** - Begin/Smith - **THAT** staff look at other areas of Burnaby where community schools might be needed.

#### CARRIED

## 8. Selection of 1995 Chairperson

Anita Loy was selected at the Chairperson of the District Community School Advisory and Coordinating Committee for 1995.

# 9. Next Meeting

It was suggested that School Trustees, City Councillors, Parks and Recreation Commissioners and Community School Council members be invited to an informal dinner which would precede the next meeting.

Francisco Salinas invited the committee to meet at Lochdale Community School on Thursday, April 6.

# 1995/96 COMMUNITY SCHOOL OPERATING BUDGET INFORMATION

- 1. Cost per community school is \$87,200.
- 2. Community school budget operates as a trust account with surplus/deficits carried forward.
- 3. 1994/95 budget \$429,870 expends a \$29,320 surplus carried forward from 1992/94 budgets.
- 4. The funding partners are being requested to provide an additional \$61,052 over their 1994/95 contributions. This is the first increase request to the funding partners in four years.
- 5. The \$61,052 increase represents three components:

14,660 (7.3%)	to bring the base up to 1994/95 level as a result of the elimin of surplus carried forward from two previous budget years	
2,792 (1.4%)	to recognize inflation costs	
43,600 (21.8%)	to fund the designation of a new community school at Edmonds	

6. Community school budget merges school district (school year July 01 - June 30) with city (calender year Jan. 01 - Dec. 31) to produce an 18 month budget cycle with a one year leap frog factor for any surplus/deficit. The following schedule may be helpful in understanding how the budget partnership works.
