#### **CARRIED UNANIMOUSLY**

a) Ms. Wendy Hankin, 1705 - 9595 Erickson Drive, Burnaby addressed Council advising that she resided in a condominium overlooking Anducci's and Red Robin Restaurants. Initially, there had been no problem with noise from 1992 to 1994 but then restaurant employees started dumping hard garbage into a garbage compactor late at night and in the early morning hours. Ms. Hankin has been in contact with the Environmental Health Department since 1994 but the problem still continues. The speaker suggested that the noise from dumping the garbage has taken away her right to peaceful sleep and to live a normal life. Ms. Hankin therefore sought fair and equitable treatment by requesting Council amend the Burnaby Noise or Sound Abatement Bylaw to address this nuisance.

Note: Item 1, City Manager's Report No. 25, 1995 May 15 was brought forward for consideration following Item (b) - Delegations.

b) Mr. Al Blush, representing St. Helen's Parish, 3871 Pandora Street, Burnaby addressed Council providing background history on the Church which was originally built in 1912 on the corner of Pandora Street and Ingleton Avenue. A new 350 seat church replaced this building in 1956 and a private elementary school was built in 1948 on the Corner of Triumph Street and Ingleton Avenue. Mr. Blush advised that because the needs of the Church and its parishioners have dramatically changed over the years, a proposal is being put forward to purchase three residential lots, consolidate the existing site with these properties and construct a new 600 seat capacity church. High density residential developments in the area and a diverse ethnic community has resulted in an increase in the congregation to 1400 members.

Mr. John Clark, representing L.O. Lund & Associates, applicant for the rezoning proposal addressed Council suggesting that P1 Neighbourhood Institutional District allows for many uses but that a new church would have the least impact on the neighbourhood. Mr. Clark stressed that the new church is intended to only serve the needs of the surrounding community. In concluding Mr. Clark encouraged a cooperative spirit with Council in order to see the rezoning progress.

1. Complaints of Late Night Garbage
Disposal Noise from Two Restaurants
at 9600 Cameron Street, Burnaby, B.C.

2. Noise from Chevron Canada Limited Refinery, 355 North Willingdon Avenue

The City Manager submitted a report from the Chief Environmental Health Officer informing Council of additional noise mitigative measures to be implemented by Chevron Canada Limited refinery and staff's' action in addressing neighbouring residents' concerns. While staff recognize that Chevron Refinery has implemented numerous noise reduction measures in their Burnaby Refinery and proposes to implement additional measures, noise generated during normal refinery operations continue to exceed the Burnaby Noise or Sound Abatement Bylaw which cannot be ignored. As such, staff are in the process of presenting a summary of charges to the Provincial Crown Council for violations of the Burnaby Noise or Sound Abatement Bylaw.

Mr. Gray further advised Council that noise levels from Chevron Refinery were amongst the lowest in the world but that Chevron will continue to monitor the situation on a regular basis.

3. Emissions of Major Pollutants from The GVRD Burnaby Incinerator

The City Manager submitted a report from the Chief Environmental Health Officer providing a summary of major pollutants emitted from the G.V.R.D. incinerator and the technology used in the incinerator to reduce mercury emissions. Average annual emissions of major pollutants from the Burnaby incinerator are well below established maximum allowable annual emission limits. The average amount of mercury emitted into the atmosphere after the installation of the activated carbon injection system at the incinerator in January 1993 was calculated to be 0.058 tonnes per year.

The City Manager recommended:

4. Concerns Related to Traffic on Winston Street at Piper Avenue

The City Manager submitted a report from the Director Engineering addressing concerns raised by Roberta and Frank Boutillier who appeared before Council as a delegation at its meeting of 1995 May 01. Staff appreciate the concerns of the delegation and regret that the maintenance of landscaping along the Winston Street boulevard adjacent Piper Avenue could not be carried out with greater sensitivity. However, staff believe that the restorative landscaping recommended will ultimately, albeit not immediately, provide a superior screening. The recommended marked crosswalk at Piper Avenue on Winston Street will address the primary traffic safety concern of the delegation and staff are also recommending the implementation of extended parking bans along Winston Street as requested by the delegation.

The City Manager recommended:

- 1. THAT Council approve the proposed restoration of landscaping along Winston Street adjacent the Boutillier residence.
- 2. THAT Council approve the installation of a marked pedestrian crosswalk of Winston Street at Piper Avenue.

#### Councillor Lawson

Councillor Lawson advised that on 1994 December 19 the Metropolitan Board of Health, the B.C. Lung Association, the Canadian Cancer Society and the Heart and Stroke Foundation of B.C. and Yukon commissioned a large scale survey of the Lower Mainland and Capital Regional District to investigate how residents deal with the impact of smoking on indoor air quality, what is the support for no-smoking bylaws being proposed to local municipalities and whether residents would change their patronage of restaurants, bars, clubs and other entertainment and gaming venues if smoking were prohibited. Councillor Lawson further advised that the Angus Reed poll results were released this morning which indicated that while only half the public is currently aware of proposed bylaws to restrict smoking in publics places, there is wide-spread support when the concept is introduced. Councillor Lawson indicated that the City of Burnaby came through with 70% in support of a 100% smoke-free indoor environment, the highest percentage recorded of those areas polled.

### Councillor Redman

Councillor Redman inquired if the Port Authority has recently taken tenants in its facility at the foot of Penzance Drive on the north side of the railroad tracks.

Mr. D.G. Stenson, Director Planning and Building responded by advising that he was aware that the Port Authority was going through a proposal call process and is specifically leaning towards small users. Mr. Stenson undertook to follow up on Councillor Redman's inquiry.
