a) <u>Steve Mancinelli</u>, 5610 Georgia Street, Burnaby appeared before Council to discuss sustainability. Mr. Mancinelli reviewed the environmentally pro-active actions of Council such as recycling and complimented Council for their actions.

The speaker discussed sustainability issues such as water quality, green space management and regional governance. Mr. Mancinelli noted that the current plans for Cariboo Hill are not acceptable as community plans. In his opinion the housing plans are a death sentence for the area wildlife and do not provide access to the urban village or access to proper transit.

In concluding, Mr. Mancinelli requested that the destructive plans for Cariboo Hill be halted and a new community planning process be initiated.

b) This delegation did not appear before Council.

c) <u>Lila Parker</u>, #202 - 5262 Rumble Street, Burnaby appeared before Council to present information on ways to accomplish a healthier and safer lifestyle. The speaker suggested that the mandate of Council includes ensuring hazardous-free industries within the community and for this reason, the speaker urged Council to voice its opposition to food irradiation, blood irradiation and bio-technology.

Councillor Rankin arrived at the Council meeting at 7:15 p.m. and took his place at the Council table.

Ms. Parker welcomed businesses into Burnaby which would focus on prevention of health problems by providing clean water, having better air quality, foods free of toxic sprays, and rejecting aerial sprays.

The speaker further supported more non-evasive health treatments that work, but to date have not been recognized by the medical community. The speaker suggested that conventional medicines do not promote healing and that people are seeking alternative natural healing methods.

Councillor Redman arrived at the Council meeting at 7:22 p.m. and took her place at the Council table.

The speaker covered a variety of global concerns related to nuclear power sources, food irradiation and blood irradiation and concluded by requesting Council carefully scrutinize any business that could be hazardous to the health of the citizens of Burnaby.

All services are to be designed to City Standards and constructed in accordance with the Engineering Design. One of the conditions for the release of occupancy permits will be the completion of all requisite services.
 - c) The installation of all electrical, telephone and cable servicing, and all other wiring underground throughout the development, and to the point of connection to the existing service where sufficient facilities are available to serve the development.
 - d) The provision of a covered car wash stall and an adequately sized and appropriately located garbage handling and recycling material holding space within the underground parking and a commitment to implement the recycling provisions.
 - e) The deposit of the applicable per unit Neighbourhood Parkland Acquisition Charge.
 - f) The granting of a 215 Covenant restricting enclosure of balconies.
 - g) The granting of any necessary easements and covenants.
 - h) The dedication of any rights-of-way deemed requisite.
 - i) Submission of a tree survey, retention of as many existing mature trees as possible on the site, protection by registration of a Section 215 Covenant of identified trees, submission of a written undertaking to ensure that all site areas identified for preservation of existing vegetation are effectively protected by chain link fencing or other approved physical containment during the whole course of site preparation and construction work, and deposit of sufficient monies to ensure the protection of identified existing vegetation, to be refunded a year after completion of construction.

- j) Compliance with the Council adopted sound criteria.
- k) The provision of a public pedestrian walkway through the site from Southoaks Crescent through to the B.C. Parkway park strip and the construction of a concrete walk and lighting to the approval of the Director Engineering.
- 1) The submission of the applicant's schedule for strata title phasing and construction of the subject proposal.

In the event that existing improvements on the site are vacant and considered to be unsafe, unstable, and a hazard to life, the Fire Prevention Office may recommend immediate demolition of such improvements and removal of the resultant debris prior to Third Reading.
- e) The satisfaction of all necessary subdivision requirements.
- f) The consolidation of the net project site into one legal parcel.
- g) The granting of any necessary easements and covenants.
- h) The dedication of any rights-of-way deemed requisite.
- i) The undergrounding of existing overhead wiring abutting the site.
- j) Retention of the identified existing mature tree on the site and its protection by registration of a Section 215 Covenant and submission of a written undertaking to ensure that all site areas identified for preservation of existing trees on and adjacent to the site are effectively protected by chain link fencing during the whole course of site construction work, and deposit of sufficient monies to ensure the protection of identified existing trees, to be refunded a year after release of occupancy permits, upon satisfactory inspection.
- k) The provision of a covered car wash stall and an adequately sized and appropriately located garbage handling and recycling material holding space within the underground parking and a commitment to implement the recycling provisions.
- 1) The deposit of the applicable per unit Neighbourhood Parkland Acquisition Charge.
- m) The granting of a 215 Covenant restricting enclosure of balconies.

Councillor Rankin

Councillor Rankin commented on an article which appeared in the 1995 December 17 edition of *The News* suggesting that the Burnaby homeowner is paying the highest water and sewer costs in the GVRD.

Councillor Rankin advised that the Director Finance has prepared and distributed a memo to Council Members clarifying that the numbers quoted in the article are GVRD estimates of the impact on a single family dwelling for all of the regional district's functions.

Councillor Drummond

Councillor Drummond advised of a 1995 December 15 Provincial Government News Release wherein it was announced that seven municipalities in Greater Vancouver have been awarded a total of \$1.24 million under the Provincial Cycling Network Program to assist in the development of local cycling infrastructure. Councillor Drummond advised that Burnaby will receive \$175,000 for improvements to seven kilometres of the Francis/Union bike route from Boundary Road at Union to Simon Fraser University and then to Barnet Highway and \$125,000 to create an on-street 2.2 kilometre-long bike route looping Metrotown.

Councillor Corrigan retired from the Council Chamber at 9:50 p.m. and did not return.

His Worship, Mayor W.J. Copeland

His Worship, Mayor Copeland advised that he had received a telephone call from Mayor Betty Toporowski, City of New Westminster regarding the recent informal meeting held between the two Councils regarding the Marine/Tenth Avenue Connector. Mayor Toporowski requested that Burnaby not act on any major traffic proposals until such time as New Westminster has had the opportunity to receive a public consensus. Mayor Copeland suggested that, with Council's approval, a letter be forwarded to New Westminster City Council requesting they forward their official position regarding this matter in writing to Burnaby City Council.

Councillor Redman

Councillor Redman advised that the Christmas Tree Recycling Program has been scheduled for 1996 January 06 and 07. Councillor Redman suggested that Burnaby citizens of Ukrainian descent do not take down their Christmas trees until after that time and that consideration should be given next year to extending the date for the recycling program.

Councillor Redman further requested that the SPCA Animal Shelter be requested to provide a year-end report listing activities for 1995.
