- Willingdon Avenue (from Hastings Street to the Chevron Refinery boundary at Eton Street) adjacent Confederation Park and the Eileen Dailly Leisure Pool.

- Lane north of the 4100 blk Hastings Street (east of Gilmore Avenue) in conjunction with the Hastings Street revitalization project.
- Bennett Street (from Nelson Avenue to Marlborough Avenue) in Metrotown, adjacent Lobley Park and the new No. 3 Firehall.
- Nelson Avenue (from Jubilee to Imperial) in Metrotown adjacent the Cenotaph area of Bonsor Park.

A letter dated 1995 September 05 was received from Mr. R.E. Free advising that the "No Left Turn" sign at Nelson Avenue onto Newton Street creates an isolating effect on his business located at 4909 Kingsway. Mr. Free suggests that the signs be changed to read "Left Turn with Caution Only".

A staff notation appended to this item of correspondence advises that the installation of the left turn restrictions at this intersection was the subject of a report to the Traffic and Transportation Committee - Traffic Safety Division for the meeting held on 1994 September 13. For safety reasons, the Committee recommended 'THAT Council approve the prohibition of all left turn movements at the intersection of Nelson/Newton'. Council subsequently adopted this recommendation at the regular meeting held on 1994 September 26.

#### 8) Exemptions from Taxation - 1996
