SUBJECT: CONTRACT NO. 9510 - CAPITOL HILL AREA  
SANITARY SEWER (PHASE II)

PURPOSE: To obtain approval to award a contract for the installation of  
sanitary sewers in the Capitol Hill area.

RECOMMENDATION:

1. THAT a contract be awarded to the lowest bidder, E.B. Friesen Associates Ltd., for the installation of sanitary sewers in the Capitol Hill area for a total cost of \$198,213.22 with final payment based on actual quantities and unit prices tendered.

REPORT

Six tenders for this contract were received by the closing time of 3:00 p.m., Monday, 1995 June 12 and were opened by staff in the presence of representatives of the firms bidding. A tabulation of the tenders received is attached (Attachment A).

The work of this contract involves the supply of all labour, materials, tools and equipment required for the construction of sanitary sewers and miscellaneous work for the Capitol Hill Sanitary Sewer (Phase II).

The Director Engineering's estimate for this work is \$235,000.00.

The recommended bidder, E.B. Friesen Associates Ltd., has completed similar construction contracts for the City, most recently Contracts Nos. 9410, 9322 and 9314. Based on their past performance, the Director Engineering is satisfied that they have the experience and resources to complete the work of this contract.

Sufficient General Revenue funds are available and expenditures are included in the 1995 and 1996 Sanitary Sewer components of the 1995-1999 Capital Program. Appearing elsewhere on the agenda is an Engineering work order report requesting funding for this project.
