## MOVED BY COUNCILLOR EVANS: SECONDED BY COUNCILLOR LAWSON:

"THAT the delegations be heard."

#### CARRIED UNANIMOUSLY

a) Mr. Allan Proctor, President, Redekop Properties appeared before Council to discuss retention of a row of eight trees located in the south central portion of lot 10 (a 41 unit town house site) in the Oaklands project, Rezoning Reference No. 34/95. The speaker noted that the grouping of trees include one ponderosa pine, one fir tree, five hemlock trees and one dead hemlock tree. Mr. Proctor presented drawings showing the configuration of units when the trees are retained and the configuration should the trees be relocated.

The delegation further advised that Redekop Properties Inc. are proposing to replace each of the eight trees with two additional trees of native species, the same height and will be of specimen quality. In summary, the speaker requested clarification as to the interpretation of Council's policy related to tree preservation within the Oaklands Development area. The speaker also noted that both the project architect and the landscape architect were present to respond to questions from Council.

Councillor Corrigan retired from the Council Chamber at 7:45 p.m.

A staff note appended to the delegation's letter advises that a compact cluster of forty foot conifers which are in basically good condition is the only group of significant trees remaining on this site.

Preservation and continuity of trees of any significance have been achieved on other Oakland sites including Rezoning Reference No. 39/95 which is proceeding concurrently with this one as the last of the Oaklands Rezoning proposals. Creative site planning solutions around existing trees have added beneficial character to new developments. If Council wishes, the Director Planning and Building can verbally elaborate on this matter at the 1995 November 20 Council meeting.

Arising from the discussion, Councillor Lawson was given leave by Council to introduce the following motion:

#### CARRIED UNANIMOUSLY

b) Mr. David Morgan, National President, Veterans Against Nuclear Arms appeared before Council to discuss the threat of nuclear testing by France and China. Mr. Morgan drew parallels between today and the cold war with respect to nuclear crises and how it affects Burnaby. Mr. Morgan noted that nuclear threats know no boundaries and as a result protests against them should hold no boundaries.

In order to protest the nuclear arms testing, the speaker advocated Burnaby Council to adopt the following resolution:

- "1. THAT Burnaby Council openly approach the Saskatchewan Government and request that:
  - Since France's current nuclear weapons test program in the South Pacific constitutes a flagrant misuse of uranium, and
  - Since France has extensive uranium mining operations in Saskatchewan,

THAT the Government of Saskatchewan take effective action to prevent any possible misuse of Saskatchewan's uranium; and

THAT Burnaby City Council openly approach the Government of Canada and request that:

- Since China has carried out nuclear weapons tests this year, and
- Since one of the by-products of the Can-Do reactor is plutonium,

THAT the Government of Canada reconsider all further steps towards the recently announced sale to China of two Can-Do nuclear reactors for power generation."

In response to the delegation's request, His Worship, Mayor W.J. Copeland called upon Councillor Doug Evans to read the proclamation recently adopted by Council which suggests that the City of Burnaby express opposition to the Government of France for their activities related to nuclear arms testing.

c) Mr. Rob De Lazzari, 7168 Ridgeview Drive, Burnaby appeared before Council to present a petition containing 86 signatures expressing opposition to the proposed extension of Dalla Tina Avenue. The text of the petition reads as follows:

"We the undersigned, residents of the Ridgeview neighbourhood on Burnaby Mountain are opposed to the proposed Dalla Tina Avenue extension 'Best Alternative Option'. We are of the view that the originally planned access to the Hastings/Gaglardi be built."

Mr. De Lazzari noted that residents are concerned about increased traffic, noise, air pollution and the environmental impact of further tree removal.

3. Burnaby Mountain Parkway: Dalla-Tina Extension Options

The City Manager submitted a report from the Director Planning and Building providing a review of the option for extending Dalla Tina Avenue to the Burnaby Mountain Parkway submitted by Mr. A. Dalla Tina, 7321 Hastings Street and to summarize the feasible options for constructing this access road. Based on staff's review, it has been concluded that the new proposal from Mr. Dalla Tina would require regrading of both Dalla Tina Avenue and Hastings Street in order to achieve a safe vertical profile and that two options are available to achieve minimum safety standards. Option A offers the 'Best Alternative' from a design perspective but intrudes significantly into dedicated park while Option B marginally meets design standards but intrudes only to a minor degree into dedicated parkland.

The City Manager recommended:

1. THAT Council approve the recommendation in the September 11, 1995 Manager's Report #41, Item 1, to request the Ministry of Transportation and Highways to modify the design of the access road as shown in Figure 5 of this report.

- 2. THAT alternatively should Council wish to recommend that the Ministry of Transportation and Highways construct an extension of Dalla-Tina Avenue to the Burnaby Mountain Parkway it approve either Option A or Option B as outlined in this report.
- 3. THAT a copy of this report be forwarded to Mr. A. Dalla Tina, 7321 Hastings Street and Mr. T. Tasaka, Project Director, Barnet/Hastings People Moving Project.

### 5. Cats

The City Manager submitted a report from the Director Finance responding to a request from Council for a report providing information on King County and other U.S. jurisdictions spaying, neutering legislation; the extent of Burnaby's cat overpopulation problem; the amount of money spent by the various organizations to spay and neuter and whether or not the SPCA provides any cost reduction to these organizations; and other low cost alternatives which may be available and further, that the report examine the feasibility of enacting mandatory licensing, spaying and neutering legislation for cats.

Staff conclude their review by advising that there are a range of available actions, as evidenced by the survey referred to in the report, and as suggested by cat welfare advocacy groups that the City could employ in an attempt to control the cat population. In view if the limited resources available for the effective enforcement of regulatory action such as mandatory spaying and neutering, and in light of the fact that the Municipal Act does not currently provide for cat licensing, an approach involving continued education about the benefits of spaying and neutering, and continued monitoring of the cat population would be appropriate at this time. Therefore, staff recommend that the City work with existing regulations for the immediate future in order to evaluate the public acceptance of the currently spay rebate program, and the effect on the number of cats handled by the SPCA.

c) SFU Liaison Committee
Re: Transfer Agreement with SFU
Burnaby Mountain Conservation Area Lands

The SFU Liaison Committee submitted a report advising of the transfer agreement with Simon Fraser University for the Burnaby Mountain Conservation Lands. The report advises that the objective of the discussions has been to achieve two desired outcomes that are believed to be of lasting and crucial interest to the citizens of Burnaby for generations to come. The first objective is the provision of a new dedicated park and conservation area for the City of Burnaby and the second objective was to provide a significant contribution to new opportunities for academic enhancement and campus development for

Simon Fraser University. The memorandum of understanding between the University and the City expresses a commitment of both parties to seek the desired results through a series of mutually dependent actions over the next several months leading to a concurrent transfer of titles to lands on Burnaby Mountain.

In concluding the report, the Committee advised that the Province, the City and the University recognize the ecological importance of the Burnaby Mountain Conservation Area in a rapidly growing region.
