**SUBJECT:** REVISION OF SCHEDULE "A" OF THE SOLID WASTE BYLAW

**PURPOSE:** To seek Council's approval to amend the charge rate structure for collection and disposal of commercial and industrial refuse.

---

**RECOMMENDATION:**

1. THAT Council approve updating of Schedule "A" of Burnaby Solid Waste Bylaw, as shown in this report; and
2. THAT the City Solicitor be instructed to prepare and bring forward the necessary Bylaw amendment; and
3. THAT the new charge rates become effective 1996 January 01.

**REPORT**

Schedule "A" of the Solid Waste Bylaw prescribes the list of charge rates applicable for the collection and disposal of commercial and industrial refuse. Current rates have been in effect since 1992 April 01 and it has become necessary to amend Schedule "A" to reflect inflationary increases in labour and materials, in addition to a projected increase in the disposal rate as indicated in the GVRD 5 year budget plan. The existing and proposed charge out rates under Schedule "A" are attached. Staff are not privy to details of the pricing structure within the private sector because of a reluctance to make such information public. However, indications are that the proposed incremental adjustments in our rate structure will still allow us to remain competitive with the private sector.
