- a) Frank and Roberta Boutilier, 3990 Piper Avenue, Burnaby, appeared before Council to speak to the report prepared by the Director Engineering which appeared as Item 4 of the City Manager's Report, 1995 May 15. The Boutiliers suggest that the proposed planting of vegetation will do nothing to alleviate the noise levels they are being subjected to and therefore maintain that the erection of a wall is the most appropriate measure to take. Being as their home faces west and is only 15 feet from Winston, they are hit with traffic noise from three sides which is destroying their quality of life.

Councillor Drummond arrived at the Council meeting at 7:21 p.m. and took his place at the Council table.

In referring to the May 15 staff report, Mrs. Boutilier expressed her support for the proposed installation of a marked crosswalk on Winston Street and further suggested that speed limit signs be erected, similar to the sign heading westbound on the Moscrop/Gilpin Connector and signs also be erected discouraging the use of truck brakes in a residential area. Mrs. Boutilier also requested installation of signs on Piper Avenue at Winston Street and at the railway tracks on Piper Avenue restricting trucks over 10,000 lbs.

The Boutiliers concluded their presentation by advising they have taken their home off the real estate market and anxiously anticipate the resolution to the traffic noise problem before the summer so they can attempt to sell their home again.

Item (b), Tabled Matters was brought forward for consideration at this time.

b) Concerns Related to Traffic on
Winston Street at Piper Avenue

Winston Street at Piper Avenue

The City Manager submitted a report from the Director Engineering addressing concerns raised by Roberta and Frank Boutilier who appeared before Council as a delegation at its meeting of 1995 May 01. Staff appreciate the concerns of the delegation and regret that the maintenance of landscaping along the Winston Street boulevard adjacent Piper Avenue could not be carried out with greater sensitivity. However, staff believe that the restorative landscaping recommended will ultimately, albeit not immediately, provide a superior screening. The recommended marked crosswalk at Piper Avenue on Winston Street will address the primary traffic safety concern of the delegation and staff are also recommending the implementation of extended parking bans along Winston Street as requested by the delegation.

The City Manager recommended:

1. THAT Council approve the proposed restoration of landscaping along Winston Street adjacent the Boutilier residence.
2. THAT Council approve the installation of a marked pedestrian crosswalk of Winston Street at Piper Avenue.
3. THAT Council approve the prohibition of stopping along both sides of Winston Street within an approximate distance of 90m from Piper Avenue.

- b) Mr. Richard Wong, 7857 Elliott Street, Vancouver appeared before Council on behalf of his nephew, Mr. Terry Wong who resides at 6539 - 12th Avenue. Mr. Wong advised that his nephew is the owner of Wong's Farm on 12th Avenue which, on 1994 June 18 was flooded as a result of a clogged sewer line on private land which was built by the City of Burnaby. Mr. Wong estimated the total loss of produce to be in the area of \$20,000 and therefore appealed to Council for relief for the loss of revenue and family assets. Mr. Wong further requested the Engineering Department to reconstruct the sewer line to prevent any future flooding of the farmland.

Mr. Terry Wong, owner of Wong's Farm, 6539 - 12th Avenue addressed Council advising that he would be grateful for any attention or consideration that Council could provide with respect to his financial loss as a result of the flooding of his farm on June 18th, 1994.

- c) Mr. Tony Laurita, 6835 Hycrest Drive, Burnaby appeared before Council on behalf of the residents of Adair Street and Hycrest Drive. The residents' objective is to attempt to conserve the only green space in the Sperling School area and are concerned that if the Sperling School day care proposal goes ahead the neighbourhood will lose the only grassy area available for recreation purposes. Mr. Laurita expressed concern with not having been included in any of the planning for this project and requested Council put a stop to the proposal and have the Day Care Committee follow proper protocol which involves a public consultation process. Mr. Laurita also informed Council that there are 30 day care facilities within a five mile radius of Sperling School and a day care on the school grounds will increase traffic congestion.

Councillor Corrigan retired from the Council Chamber at 7:45 p.m.

In concluding, Mr. Laurita advised that he had received notice on Saturday that there will be a public consultation process and felt that this notice was only motivated by the fact that he was appearing before Council this evening.

4. Sperling School Day Care Facility Proposal

The City Manager submitted a report from the Director Planning and Building providing Council with information requested in connection with correspondence and a petition received on May 15, 1995 from Hycrest area residents pertaining to the subject day care facility proposal. The application for the proposed daycare must meet the Burnaby Zoning Bylaw requirements for the placement of accessory buildings in the P3 District, prior to the issuance of Preliminary Plan Approval.

Staff remove such signs as encountered but do not have resources that could cost-effectively be dedicated to a removal program. Staff's actions have been explained to the correspondent.

Provision for accessibility to the Court House is a reflection of the City's ongoing commitment to ensure access to the City's facilities and services to all Burnaby residents. Access for persons with disabilities is included in the planning for all new City facilities, and when renovations are done at City-owned venues, the work includes provision for access to persons with disabilities.

Councillor Corrigan further advised that, in his capacity as Acting Mayor, he had the pleasure and privilege of being present at the Shadbolt Arts Centre to receive a cheque from the Provincial government in the amount of \$666,000 which represents 2/3 of the \$1 million commitment by the Provincial government towards the Arts Centre. Councillor Corrigan wished to commend the Arts Centre Capital Campaign Committee and the Provincial MLA's who worked very hard and lobbied on Burnaby's behalf.

In concluding, Councillor Corrigan advised that he had participated in the Great Transit/Bike/Car Race sponsored by B.C. Transit which started at Broadway and Nanaimo and finished in the 700 block West Pender Street, Vancouver. Councillor Corrigan indicated that even though the transit team did not win the race they beat the automobile to the finish line by 15 minutes.
