PURPOSE:

To seek Council authorization to approve the low level family fireworks

display at Seton Villa Retirement Centre

RECOMMENDATIONS:

1. THAT the request to discharge low level family fireworks at Seton Villa Retirement Centre ~ 3755 McGill Street on 1995 June 30 between 09:00 pm and 10:30 pm, be approved subject to full compliance with all the conditions as required by the City of Burnaby.

2. THAT a copy of this report be forwarded to Pat Argent, Recreation Director of Seton Villa Retirement Centre ~ 3755 McGill Street, Burnaby, B.C. V5C 1M2.

<u>REPORT:</u>

The use, discharged low level family fireworks is permitted by Bylaw to take place in the period of October 25 through 31 each year. However, Section 933.1(a) of the Municipal Act permits Council to authorize the issuance of a permit to a person or organization for the purpose of the observance or celebration of a special event or festival by the use of fireworks of any kind and may specify terms and conditions.

Attached is a copy of a letter received from Seton Villa Retirement Centre requesting permission to hold a low level pyrotechnics display of 1995 June 30 from 09:00 pm and 10:30 pm. The purpose of this report is to authorize, with Councils approval, the use of low level family fireworks for this celebration with the following comments and conditions.

The Burnaby Fire Department has no objections to the subject display provided that:

- 1. Full compliance with the Burnaby Fire Department Fire Bylaw Part V, pertaining to fireworks.
- 2. This display complies with the Explosive Act of Canada
- 3. A site diagram is provided showing:
 - a) area where the low level fireworks will be set off.
 - b) area where the low level fireworks will be stored.
 - c) location of at least 2 ~ 5 lb. ABC dry chemical fire extinguishers at the display site
 - d) location of exits from the display site.
- 4. Seton Villa Retirement Centre provides proof of a minimum of Two (2) Million Dollars Liability Insurance, the City of Burnaby named as an additionally named insured for this event. The policy must include a Cross Liability Clause and a thirty (30) day written Notice of Cancellation Clause. In addition, a "copy" of this Liability Insurance is to be mailed to the Fire Prevention Division.
