SUBJECT: CONTRACT NO. 9417 - TRAFFIC CONTROL DEVICES
VARIOUS LOCATIONS

PURPOSE: To obtain approval to award a contract for the supply and
installation of traffic control devices at various locations.

RECOMMENDATION:

1. THAT a contract be awarded to the lowest bidder, Guild Electric Ltd., for the supply and installation of traffic control devices at various locations for a total cost of \$178,170.74 with final payment based on actual quantities and unit prices tendered.

REPORT

Five tenders for this contract were received by the closing time of 3:00 p.m., Tuesday, 1995 January 24 and were opened by staff in the presence of representatives of the firms bidding. A tabulation of the tenders received is attached (Attachment A).

The work of this contract involves the supply of all labour, materials, tools and equipment required for the installation of traffic control devices at Union Street and Sperling Avenue, Moscrop Street and Wayburne Drive, Parker Street and Springer Avenue, Imperial Street and Mandy Avenue, Imperial Street and Gray Avenue.

The Director Engineering's estimate for this work is \$210,000.00.


The recommended bidder, Guild Electric Ltd., has been in business in the lower mainland for two years and has 30 years experience across Canada. Guild Electric Ltd., has not performed work with the City but has completed contracts with The City of North Vancouver, District of North Vancouver, Corporation of Delta and the Ministry of Transportation and Highways. Our consultant has contacted these agencies and has received satisfactory references. The Director Engineering is satisfied that Guild Electric Ltd., has the experience and resources to complete the work of this contract.
