1995 LOCAL IMPROVEMENT PROGRAM

PURPOSE:

To obtain approval of the cost report for the 1995 Roadworks

Local Improvement Program.

RECOMMENDATIONS:

- 1. THAT Council adopt the local improvement cost report as shown on Schedule 1; and
- 2. THAT on receipt of the cost report, the City Solicitor prepare Local Improvement Construction Bylaws for each of the successful roadworks projects.

REPORT

On 1995 January 23, Council received the City Clerk's Certificate of Sufficiency covering the 1995 Local Improvement Roadworks Program. Section 662 of the Municipal Act requires that a cost report related to the work be approved by Council prior to the adoption of the construction bylaw. The cost report must include:

- a) the estimated life of the work:
- b) the estimated cost of the work; and
- c) the share of proportion of the total cost which will be specifically charged against the parcels benefitting from or abutting on the work.

The cost report (Schedule 1 <u>attached</u>) summarizes the 1995 Roadworks Program by project, and identifies the commuted payment which may be made by the property owner whose parcel is subject to charge, in lieu of the 15 year frontage tax levy.
