Councillor Young arrived at the Council meeting at 7:02 p.m. and took his place at the Council table.

Avenue, Burnaby, B.C. appeared before Council to offer comments arising from recent questions raised in Council, and also to answer any questions Council and staff may have. Mr. Haslam advised that in 1974, Chevron embarked on a refinery modernization and at that time made a significant effort to improve relations with the community in terms of landscaping, buffer zones, noise control and other initiatives which brought Chevron to a new and improved inter-face with the neighbourhood. Since that time, Chevron has introduced many improvements such as a vapour recovery system and a new wharf; however, recent concerns expressed by some of the neighbours suggests that Chevron has not kept pace with changing demographics and expectations in the community.

Mr. Haslam suggested that Chevron has slipped recently and has not done as good a job in communicating as they may have and have not lived up to the standards the Company set for themselves or the neighbour's expectations. The speaker submitted that Chevron has learned from this and are taking the following steps in response to concerns that have been raised:

- Contractors who were parking along Eton Street are now parking in our parking lot instead.
- Dropping plans to relocate the truck weigh scale and asphalt loading rack.
- Committing to retain the current fence line along the lane north of Eton Street and to leave Chevron's property on Eton Street in the block between Rosser and Madison Avenues as open green space.
- Renewed the earlier commitment to Burnaby to co-fund hiring a landscape architect to develop a master landscaping plan for the entire Chevron buffer zone area. Chevron encourages Burnaby Parks and Recreation Commission to proceed without any further delay.
- Planning to form a Community Advisory Panel to improve two-way communication between Chevron and its neighbours.

With respect to the staff report before Council, Mr. Haslam assured Council that Chevron is investigating the use of truck transportation and alternatives to reduce the amount of traffic in the neighbourhood and further, regarding tank storage and Chevron's PPA for replacement tankage, Chevron have paused their project to see if they can improve their plans to reduce expected emissions and odours.

Councillor Rankin arrived at the Council meeting at 7:03 p.m. and took his place at the Council table.

Councillor Redman arrived at the Council meeting at 7:04 p.m. and took her place at the Council table.

In concluding his presentation, Mr. Haslam hoped that these actions demonstrate Chevron's commitment to work with its neighbours and to help open the lines of communication again.

Councillor Corrigan arrived at the Council meeting at 7:08 p.m. and took his place at the Council table.

Mr. San Khanna, 6599 Russell Avenue, Burnaby appeared before Council to discuss matters pertaining to Subdivision Reference No. 4/94. Specifically, Mr. Khanna addressed the continued withholding of a letter of credit for the protection of three trees and further, a covenant and letter of credit pertaining to a stone wall at the front of his property. Mr. Khanna advised that the trees seem to be in good health now and into their second growing season and therefore the letter of credit should be released by the City. With respect to the stone wall, he was informed by the Engineering Department that a sewer connection would have to be made and that this work would not commence until such time as the wall was removed. Mr. Khanna advised that he subsequently removed a portion of the stone wall and a sewer connection was made. In concluding his comments, the speaker suggested that the City should be responsible for fixing the section of the wall that was removed in order to accommodate the sewer connection or, barring this, that the covenant should be removed and that the maintenance and retention of the wall be left to the discretion of the property owner.

Arising from the delegation's presentation, Councillor Drummond was given leave by Council to introduce the following motion:

Ms. Antonia Beck, Co-Chair of the South Burnaby Neighbourhood House Society, 6328 Marine Drive, Burnaby appeared before Council accompanied by the Society's Chair, Ms. Carol Ann Marley. Ms. Beck advised that the South Burnaby Neighbourhood House Society is a group of citizens and service providers who have been meeting since August 1994 to establish a neighbourhood house in south Burnaby. The mission of the Society is to make neighbourhoods better places to live and the goal is to enable people to enhance their lives and strengthen their communities. The Society's challenge is to work with communities to develop innovative programs and services that meet the changing needs of a diverse population. The speaker suggested that the neighbourhood house would be guided and directed by a volunteer board of management comprised of community members. Incorporated as a Society, the South Burnaby Neighbourhood House Society has received start-up support from the Alexandra Foundation which is administered by the Association of Neighbourhood Houses of Greater Vancouver.

In her concluding comments, Antonia Beck requested Council's support for a neighbourhood house in the south Burnaby area and requested Council's consideration of providing a location for the facility.

10. Chevron Canada Limited Burnaby Refinery

Staff advised that Chevron officials have responded to the strongly expressed concerns of Council and area residents by providing information on certain questions, by sending out a newsletter to nearby residents expressing their willingness to listen and review their plans and to concentrate on improving their communication with local citizens, and by withdrawing their proposal to relocate the fence, create new parking lots and relocate the asphalt loading rack and weigh scale in this area. Chevron have renewed their earlier commitment to co-fund the engaging of a landscape architect to develop a master landscaping plan for the entire buffer area and have committed to maintaining off-street parking for contractors working at the refinery. Further Chevron advised that they are planning for the formation of a Community Advisory Panel to enhance communication with their neighbours.

The New Westminster program, which focuses on multi-family buildings, is modelled on successful programs in forty states in the United States that such programs exist. The New Westminster program has been in operation since June 1995 and, to date, the managers of 50 rental complexes have signed on to the program. The purpose of the program is to educate landlords and tenants to improve the livability of neighbourhoods by reducing crime.

7. Brentwood Town Centre Development Plan
Phase III of Development Plan Review Process

The City Manager submitted a report from the Director Planning and Building providing the finalized Brentwood Town Centre Development Plan for Council's consideration and approval. Staff advised that the finalized development plan is the result of an extensive coordinative and public consultation process. The plan is considered to reflect a balanced and responsible approach to the redevelopment of this area and meeting growth objectives for the City vis-a-vis the region. In focusing redevelopment in the town centre with its transportation and urban amenities, there will be overall benefits to the City as a whole.

"THAT WHEREAS the rivers, streams and creeks in the City of Burnaby provide important salmon rearing habitat, and

WHEREAS the citizens of Burnaby have been actively involved in protecting and enhancing the habitat value of specific rivers, streams and creeks in the City, and

WHEREAS Council recently adopted a Streamkeepers Program to initiate a comprehensive community - based stewardship of the City's rivers, streams and creeks, and

WHEREAS rivers, streams and creeks in urban areas have, historically, been impacted by adjacent development leading to increased sedimentation, loss of vegetation and deterioration of water quality, and

WHEREAS the Outdoor Recreation Council, in their 1996 Endangered Rivers list, identified Urban Streams as the second most threatened river system in the Province of British Columbia, and

WHEREAS Federal Government resources to oversee the protection of rivers, streams and creeks becomes more stretched, and

WHEREAS sedimentation in rivers, streams and creeks adversely impacts fish habitat by increasing suspended solids, blanketing spawning beds, and potentially changing stream profiles and flow characteristics, and

WHEREAS a number of streams in the City of Burnaby have recently been adversely affected through sedimentation, and

WHEREAS no City bylaws are currently in place that address specific sediment limits above background levels in urban rivers, streams and creeks;

THEREFORE BE IT RESOLVED THAT

Staff investigate the advisability and feasibility of developing a sediment control bylaw that includes specific sediment threshold limits for rivers, streams and creeks, and appropriate fines; and concurrently, that staff investigate if sediment control guidelines would be preferable to a sediment control bylaw as a means to enforcing regulations and protecting the habitat values of urban rivers, streams and creeks."

CARRIED UNANIMOUSLY

Councillor Rankin

Councillor Rankin advised that, during the recent Provincial Election Campaign, he had noted that election signs had been placed on the cenotaph on Imperial Street and suggested that, for the purposes of the upcoming local government elections, that all political parties be reminded that political signs are not permitted on park property.

Councillor Young inquired as to whether staff would be reviewing policies and procedures with respect to the Local Improvement Program as it relates to boulevards.

In response, the Director Engineering advised that staff are in the process of looking at the 1997 LIP Program and at the same time will review the standard of work and subsequently report to Council.

Councillor Young further inquired as to the administration of the False Alarm Bylaw pertaining to properties which facilitate more than one business.

In response, the Director Finance advised that False Alarm fines are levied against the property owner. If the property owner is fined as a result of exceeding the maximum of three false alarms, it is the property owners responsibility to determine how the fine is applied to the offending businesses.

Councillor Dummond retired from the Council Chamber at 9:20 p.m.
