At its meeting of 1996 January 08, Council received a letter from Prince Rupert Councillor Evelyn Brasso requesting Council lend its voice in protesting cuts to the Canadian Broadcasting Corporation's budget. Councillor Brasso asked Council to pass a motion of support for the CBC which

would be sent to the Federal Heritage Minister and Local MP's. She included a sample resolution on the matter for Council's consideration.

The City Manager submitted a report from the Fire Chief, the Officer in Charge, RCMP and the Emergency Planning Coordinator providing additional information on the City of Vancouver's request for Burnaby to become involved in a Centre for the Regional Coordination of Responses to major emergencies. Staff advised that the proposal presents an opportunity to develop an effective regional emergency coordination centre which, in staff's view, would constitute a significant enhancement to the emergency response capability in the Lower Mainland.

The City Manager recommended:

- 1. THAT approval be given for Burnaby to become a participating partner in the Regional Emergency Coordination Centre subject to the understanding that:
 - a) the one-time \$75,000 (estimate) capital cost be paid to the City of Vancouver in one sum in early 1997; and
 - b) the ongoing annual operating cost be paid to the City of Vancouver commencing in 1998 (currently estimated to be \$1,100 a year); and
 - c) a further report be submitted to Council if costs should become significantly higher than estimated, or if in staff's opinion there is not sufficient participation by other municipalities and response organizations to make the Coordination Centre functionally viable.
