SUBJECT: CONTRACT NO. 9601 -
1996 WATERMAIN REPLACEMENT PROGRAM - PHASE 1

PURPOSE: To obtain approval to award a contract for construction of watermains and related works at various locations.

RECOMMENDATION:

1. THAT a contract be awarded to the lowest bidder, Pedre Contractors Ltd., for the construction of watermains and related works at various locations for a total cost of \$682,253.40 with final payment based on actual quantities and unit prices tendered.

REPORT

Eleven tenders for this contract were received by the closing time of 3:00 p.m., Thursday, 1996 February 22 and were opened by staff in the presence of representatives of the firms bidding. A tabulation of the tenders received is attached (Attachment A).


The work of this contract involves the supply of all labour, materials, tools, plant and equipment required for the construction of watermains and related works at various locations within the City.

The Director Engineering's estimate for this work is \$792,281.50.

The recommended bidder, Pedre Contractors Ltd., has satisfactorily completed watermain construction contracts for the City. Based on their past performance, the Director Engineering is satisfied that they have the experience and resources to complete the work of this contract.

Sufficient General Revenue funds are available and this project is included under the 1996 Water Utility component of the 1996-2000 Provisional Capital Program. Appearing elsewhere on this agenda is the work order report on this project.

The Director Engineering and our consultant, R.F.Binnie & Associates Ltd., concur with the above recommendation.
