SUBJECT: CONTRACT NO. 9606 - SUPPLY AND INSTALLATION
OF MACHINE LAID ASPHALTIC CONCRETE AND
ASPHALTIC CONCRETE GRINDING

PURPOSE: To obtain approval to award a contract for machine laid asphalt and asphalt grinding.

RECOMMENDATION:

1. THAT a contract be awarded to the lowest bidder, Grandview Blacktop Ltd., for the supply and installation of machine laid asphaltic concrete and asphaltic concrete grinding at various locations throughout Burnaby for a total cost of \$1,731,475.48 with final payment based on actual quantities and unit prices tendered.

REPORT

Six tenders for this contract were received by the closing time of 3:00 p.m., Thursday, 1996 April 25 and were opened by staff in the presence of representatives of the firms bidding. A tabulation of the tenders received is attached (Attachment A).


The work of this contract involves the supply of all labour, materials, tools, plant and equipment required for the grinding of approximately 77,000 square metres of existing asphalt, the laying of approximately 24,000 tonnes of asphalt and other miscellaneous work at various locations throughout Burnaby.

The Director Engineering's estimate for this work is \$2,145,000.

The recommended bidder, Grandview Blacktop Ltd., has been in business in the lower mainland for approximately 26 years and has satisfactorily completed similar contracts for the City in the past. Based on their past performance, the Director Engineering is satisfied that they have the experience and resources to complete the work of this contract.

Sufficient General Revenue funds are available and this project is included under the 1996 Street and Lane Rehabilitation component of the 1996-2000 Capital Program. Funds are also available under the Engineering Service Centre and Parks Maintenance Operating accounts.

The Director Engineering concurs with the above recommendation.
