SUBJECT:

1997 BUSINESS LICENCE FEES

PURPOSE:

To propose there be no change to the business licence fees for 1997.

RECOMMENDATION:

1. THAT there be no change in business licence fees for 1997; and

2. THAT the City Solicitor be authorized to forward a repeal bylaw for the Barber Shops Regulation Bylaw 1954, Bylaw No. 3426.

REPORT

This is the annual business licence fee report. No change in business licence fees is proposed for 1997 (Schedule A, attached). Fees are reviewed and, if necessary, adjusted annually to reflect changes in the business community and inspectional requirements, and to ensure all administrative and inspectional costs are covered. These costs include inspectional and clerical staff salaries, supplies, transportation and administrative costs of the City departments involved in the licencing process.

The current (1996) basic licence fee for a typical Burnaby based business is \$426 for a new licence and \$125 for a renewal. The current fee for a non resident business operating in Burnaby is \$237 for a new licence and \$63 for a renewal.

The difference between the fee for a new and a renewal licence represents the non-recurring inspectional costs incurred by City departments prior to issuing a business licence. These inspections are required to determine if business operators are in compliance with applicable bylaw and statutory requirements which ensure public health and safety. Businesses requiring more than the basic inspections (e.g. arcades, restaurants, chemical processing and auto paint facilities) have higher fees to reflect the additional costs. Conversely, where inspectional requirements are minimal, the licence fee is lower.

As a housekeeping issue, a repeal bylaw is recommended for the Barber Shops Regulation Bylaw 1954, Bylaw No. 3426. This bylaw, which fixed hours of operation for barber shops under the old Shops Regulation and Weekly Holiday Act, is no longer applicable and may be removed from the active records.
