Official Document Signing City of Burnaby/Simon Fraser University Transfer of Burnaby Mountain Conservation lands from Simon Fraser University to City of Burnaby

His Worship, Acting Mayor Corrigan formally recognized the following dignitaries who were in attendance at the Council meeting for the purpose of witnessing the official document signing between Simon Fraser University and the City of Burnaby for the transfer of Burnaby Mountain Conservation lands:

By way of introduction, His Worship, Acting Mayor Corrigan advised that the City of Burnaby and Simon Fraser University have been engaged in a process of historic significance over recent months which led to the transfer of ownership of a significant area of land on Burnaby Mountain for conservation park purposes, which simultaneously enabled the University to pursue residential neighbourhood development within portions of their lands. A feature of community benefit associated with this transaction is Simon Fraser University's agreement to transfer *fee simple title* to Burnaby of approximately 773 acres of land outside the ring road for use as a City of Burnaby park in return for transfer of approximately five acres within the ring road owned by the City, as well as the provision of \$10 Million dollars in land value from the City and \$5 Million dollars from the Province's Lower Mainland Nature Legacy Project to establish the University's Burnaby Mountain Endowment Fund.

His Worship, Acting Mayor Corrigan then invited Dr. John Stubbs, President of Simon Fraser University to come forward and jointly sign the official document transferring the Burnaby Mountain Conservation Lands from Simon Fraser University to the City of Burnaby.

Dr. John Stubbs, President, SFU addressed Council and reaffirmed the respective commitments of good faith in implementing the plan for development, demonstrating the best practices of environmental stewardship, sensitivity to important values respecting the Mountain, and compliance with the provisions of the Official Community Plan. Dr. Stubbs advised that it had been a tremendous personal and professional pleasure to work together with Mayor Copeland, Burnaby MLA's and Burnaby staff and recognized the contributions that they brought into the process. In concluding his comments, Dr. Stubbs advised that thirty one years ago, on September 09, 1965 Simon Fraser University officially opened its doors. Dr. Stubbs felt that the signing this evening was not ironic but symbolic of the relationship shared between Simon Fraser University and the City of Burnaby.

- 4. THAT a notice be sent to residents and property owners in Neighbourhoods 2, 3 and 4 in the South Slope area west of Patterson Avenue advising them of the results of the survey and Council's direction.

For B.C. Rivers' Day 1996 on September 29th, the Environment and Waste Management Committee, with the cooperation of CUPE Local 23, wishes to coordinate the environmental stewardship projects and events outlined in the report.

The City Manager submitted a report from the Director Planning and Building presenting a proposed land use concept planned for the Burnaby Business Park lands in the Big Bend area. The land use concept plan detailed in the report and supported, in part, by the G.G. Runka Land Sense Ltd. "Land Capability and Crop Suitability for Agriculture" and "Agricultural Development Concept Plan" reports has evolved from a constructive, cooperative process involving BBP, City and ALC staff. It is staff's view that the proposed land use concept meets the objectives and principles established by the Agricultural Land Commission and the City and therefore a recommendation has been advanced that Council endorse the concept. If the land use concept is also endorsed by the Agricultural Land Commission, the next step in the process will be to prepare and submit an implementation program for the consideration of the Commission and City Council.

2. Burnaby Lake Sports Complex Development Concept

The City Manager submitted a report from the Director Planning and Building proposing a revision to the Burnaby Lake Sports Complex Development Plan Concept in the Central Valley area. Given the past issues and interest associated with this area, staff recommends that Council endorse the proposed concept plan in principle as a basis for a review of the plan by the Parks and Recreation Commission, the Environment and Waste Management Committee and the Traffic and Transportation Committee (Transportation and Transit Division). Upon completion of these reviews, the lands in the final plan designated for sportsfields, conservation and ancillary uses can be rezoned to P3 (parks and public use) for administration by the Parks and Recreation Commission.

The City Manager recommended:

- 1. THAT Council endorse in principle the revised Burnaby Lake Sports Complex Plan Concept as outlined in this report as a basis for review and comment by the Parks and Recreation Commission, the Environment and Waste Management Committee and the Traffic & Transportation Committee (Transportation & Transit Division).

In response, the Director Planning and Building advised that staff had been vigorously pursuing options for relocation of No. 5 Firehall and meetings are currently taking place with respect to this top priority.

The award will be presented at the Penticton Conference of the Associated Boards of Health to be held September 14th and 15th.

Councillor Lawson reminded Council of the Notice of Motion adopted by Council in April 1993 to protect watercourses, lakes and receiving waters from problems of sediment discharges. Staff further came forward with a report in June of that year on the administrative procedural changes and improvements respecting silt control in watercourses adjacent to development sites. Staff also brought forward a recommendation to enhance public awareness. Councillor Lawson requested that staff review the effectiveness that the changes have brought and bring forward a report.
