- a) **Don Copan**, President of the Burnaby Multicultural Society, 4667 Highlawn Drive, Burnaby appeared before Council accompanied by Ms. Susan French, Executive Director of the Burnaby Multicultural Society requesting Council's consideration of an annual sustaining grant such as those given to other agencies in the Willingdon Heights Resource Centre. Mr. Copan provided Council with an overview of the history of the Burnaby Multicultural Society which has been active in Burnaby since 1982 and formally organized in 1984. For many years the Burnaby Multicultural Society has assisted the City in its plans to observe Multicultural Week and the International Day to Eliminate Racism. The Society has also hosted workshops on cross-cultural communication and dealing with racism to employees of the City's community centres and library. The work of the Burnaby Multicultural Society has contributed to the knowledge and skill of many people living and working in Burnaby. Mr. Copan further advised that two and a half years ago the Society began its settlement and integration service for immigrants to Burnaby and the program has been extremely successful. In the first eight months of 1996, the program served 2,249 clients and a full report on this program has been provided to all Council members under separate cover.

In concluding his comments, Mr. Copan advised that the increase in demands for goods and services, the investment of capital, and the entrepreneurial activity of immigrants has added to the wealth of Burnaby and increased employment opportunities. Therefore the Burnaby Multicultural Society is in need of core funding which will permit them to carry on appropriate administration and support to services and public education in a responsible and effective manner, something which they find difficult to do with much of the funding they receive now which covers only specific projects. The Burnaby Multicultural Society respectfully requested that Council acknowledge the work and efforts of the Society in the Community and award a sustaining grant of \$10,000 annually.

- b) **Robert Lee**, 4186 Napier Street, Burnaby appeared before Council to complain about the lighting which has been installed in the laneway behind his property. Mr. Lee advised that the streetlight causes a detrimental effect on his quality of living in that the light constantly shines into his home and he is, therefore, unable to sleep. The speaker advised that his complete back yard is lit up like a prison yard and that he and his family have been deprived of their privacy. Mr. Lee advised that he has been a resident at this same address for twenty five years and, despite the fact other neighbours, had requested improved lighting as a crime prevention measure, he has never experienced any crime in his neighbourhood.

In concluding his comments, the speaker requested that the wattage in the street lighting be reduced and that the streetlight located at the east end of the alley on the second pole which affects his property be relocated to the third pole.

- a) The City Manager presented Report No. 02, 1997 January 13 on the matters listed following as Items 01 to 10 either providing the information shown or recommending the courses of action indicated for the reasons given:

1. Planning and Provision of School Facilities

The City Manager submitted a report from the Director Planning and Building providing the information requested on the planning and provision of school facilities arising from continued population growth in the City. The report responds to a Council discussion on Rezoning Reference No. 39/96 where a number of questions were raised with respect to current and future enrollment issues. Council requested information on the plans, strategies and initiatives currently in place to enable Burnaby schools to accommodate enrollment increases arising from continued population growth, increased residential development and demographic changes in the community.



Staff advised that Planning staff and School District staff meet on a regular basis to review development proposals and project enrollment implications. On major projects such as the Simon Fraser University Development Plan, the Oaklands and the Edmonds and Brentwood Town Centres there is more focus discussion with the School District during the preparation of the plans. Staff recognize, however, that the School District's ongoing ability to appropriately respond to increasing enrollment pressures, through the established approaches to school planning and capital budgeting is of growing concern given the lack of any significant excess capacity in the Burnaby school system. Both Planning and School District staff believe that some systemic changes in the existing school planning and capital funding processes are needed to address existing needs in Burnaby and emerging trends being established through the livable region strategic plan. Staff advised that some steps towards this end are underway.

The proposed development is in conformance with the existing M2 zoning and the applicant is aware of the town centre development plan and has informed staff of his long term intention to redevelop in accordance with the plan.

3. Liability Claims

The City Manager submitted a report from the Director Planning and Building providing information regarding the status of initiatives to reduce the City's potential exposure to construction related liability claims. The report was prepared arising from Council's consideration of a recent claim pertaining to the failure of a post tension structure to perform as designed. While the City maintained its position of assuming no responsibility for either the structural design or inspection of structural elements, it was named as a co-defendant in the suit. Staff recommend that the City should continue to utilize the options provided in the Municipal Act to reduce the potential exposure to liability claims. As identified in the report, a number of initiatives have been completed or are under way to deal with other concerns identified in reports by both the Closkey Commission and the Provincial Government with industry participation. However, some of the concerns identified regarding joint and several liability, accountability commensurate with responsibility, qualifications, education, warranty and insurance remain outstanding and require a concerted effort to bring them to a successful conclusion.

4. Proposal for a Successor Organization,  
Fraser Basin Management Board

The City Manager submitted a report from the Director Planning and Building providing information regarding the City's support for a proposed successor organization for the Fraser Basin Management Board. The City of Burnaby is a member municipality of the Fraser Basin Management Program and has provided funding for the program which will complete its five year mandate in May of 1997. The GVRD has requested feedback from all member municipalities on the successor organization proposal by mid-January, 1997. The report concludes by advising that there is benefit to having an organization that promotes communication and cooperation in sustainability planning for the entire Fraser Basin. Such a watershed-based approach to management builds trust that all stakeholders are committed to improving sustainability which is important in a basin where biodiversity in the lower reaches is essential to biodiversity in the head waters and vice-versa as is the case in any salmon-bearing river.

The City Manager recommended:

1. THAT the City support the proposed successor organization of the Fraser Basin Management Board through participation by the GVRD in an organization involving the participation of the 7 regional districts within the Fraser Basin.

2. THAT Council support a funding strategy for the successor organization whereby the GVRD institutes a regional levy for Fraser Basin planning of 20 cents per capita of which 10 cents per capita is already accounted and thereby credited for in the region's contribution to the FREMP and BIEAP.

4. THAT a copy of this report be forwarded to the Environment and Waste Management Committee for information.
