#### **CARRIED UNANIMOUSLY**

a) Mr. Jan Turci, Post Office Box 8000 - 705 Abbotsford, B.C. appeared before Council representing the organization known as "Fight Ordinances & Restrictions to Control & Eliminate Smoking" (FORCES). Mr. Turci advised that he appreciated the opportunity to share his perspective on the issue of smoking and second-hand smoke in public and private places which may not have been sufficiently emphasized by the business or public health delegations that have come forward. Mr. Turci discussed what was, in his opinion, unproven claims regarding the dangers of second-hand smoke and provided Council with documentation and statistics to support his position.

Councillor Redman arrived at the Council meeting at 7:05 p.m. and took her place at the Council table.

Councillor Rankin arrived at the Council meeting at 7:06 p.m. and took his place at the Council table.

The speaker referred to the anti-smoking movement as an industry which is financed by the government. Smokers have also been accused of being a cost to society and the speaker refuted this claim based on many studies and statistics available.

In concluding his comments, Mr. Turci suggested that the second-hand smoke health scare is just that. Mr. Turci suggested, with some concern, that the anti-smoking movement may escalate to the point where smokers will be restricted from smoking in their own homes when a non-smoker is present. The speaker then requested Council to take notice of the recent activities in the City of Toronto with respect to the anti-smoking bylaw which City Council has suspended for a two year period due to the economic impact.

Arising from the delegation's presentation, Councillor Volkow was given leave by Council to introduce the following motion:

The votes being recorded as equal both for and against the question, the motion was declared **NEGATIVED** and **LOST**.

b) Mr. Charles Boyd, 3875 Frances Street, Burnaby appeared before Council advising that he was unable to attend Public Hearings held regarding the Nis'ga Agreement and therefore wished to offer his testimony to Burnaby City Council in support of the agreement.

Councillor Volkow retired from the Council meeting at 7:30 p.m.

Mr. Boyd advised of treaties made with native people in the early days which were not honoured, therefore forcing the natives to adopt the customs of the white man. The speaker felt that the Nis'ga People deserved to be fairly compensated and that the Nis'ga Agreement is a fair and equitable way to provide them with what they are entitled to.

Councillor Volkow returned to the Council Chamber at 7:34 p.m. and took his place at the Council table.

In concluding his comments, Mr. Boyd advised Council that he had the opportunity to participate in a "pow wow" with the Squamish Indian Band where he learned how the natives celebrate. Mr. Boyd advised that the "pow wow" was a very joyful celebration and that he was uplifted spiritually by the experience.

Ms. Judy Cooke, 6863 Mandy Street and Ms. Sandy Curtis, 5619 Portland Street appeared before Council in support of an 'off leash' dog area in Burnaby Foreshore Park. The speakers advised that they have been very cooperative with the Parks and Recreation Department over the past year in trying to coordinate an 'off leash' dog park from Sussex Creek to Boundary Road but the Parks Department only supports the 'off leash' area on the Patterson trail portion at Burnaby Foreshore Park. The speakers provided a map showing the entire Foreshore trail and highlighted the preferential route which they felt was more sensible than that being proposed by the Parks Department. In concluding their comments, the delegation advised that they have proposed a workable solution which minimizes potential conflict and encourages park use and requested that Council include the westerly portion of the Foreshore Park with the recommendations for dogs 'off leash' areas.

Councillor Corrigan retired from the Council Chamber at 7:59 p.m.

An article outlining existing City services assisting community groups will be printed in Information Burnaby.

The Environment & Waste Management Committee submitted a report advising that it had reviewed the need to protect fish and habitat in urban streams. The Committee expressed much concern regarding the impact of rapid urban development on salmon and fish habitat and therefore prepared the following resolution for Council's endorsement:

"WHEREAS the Outdoor Recreation Council of B.C. has identified urban streams at the top of the province's most endangered rivers list; and

WHEREAS urban streams provide important fish habitat and natural open space opportunities; and

WHEREAS the City of Burnaby has taken a leadership role in its management of urban streams and has protected its urban streams through a multiplicity of measures, including the Open Creeks and Watercourse Policy, the Watercourse Bylaw, and the implementation or urban stormwater management measures; and

WHEREAS not all municipalities protect and manage urban streams similarly; and

WHEREAS there is a need for a provincial and regional framework for urban stream fish and habitat protection;

THEREFORE BE IT RESOLVED THAT Council forward this motion to the Province, and request

THAT the Province consider a provincial and regional framework incorporating measures to protect fish and habitat in urban streams through legislation, and

THAT guidelines addressing such factors as keeping urban streams open and free flowing, the removal of stream side vegetation, limiting siltation and protecting habitat be considered in such legislation recognizing that it may not always be achievable given unique local site conditions, and

THAT the Province consider amending Section 942.12 of the Growth Strategies Act and Section 945 of the Municipal Act (Content of Official Community Plans) to incorporate the above types of measures, and

THAT the Urban Salmon Habitat Program be continued."

The Environment & Waste Management Committee recommended:

1. THAT Council endorse the resolution attached to this report.
