RECOMMENDATION:

1. THAT a grant in the amount of \$1,500 be awarded to Burnaby Arts Council to assist with the archiving of records in storage at Burnaby Arts Council office.

An application was received requesting a grant to assist with the archiving of records in storage at the Burnaby Arts Council office. This material has suffered water damage and there is also evidence of mold and insect infestation. The intention is to prepare the records for transfer to and storage at the Burnaby Village Museum Archives.

In addition, 7,446 new toys were provided for children to enjoy.

The Centre was formally established by the Federation of Canadian Municipalities in partnership with the Indian Taxation Advisory Board as a resource centre supporting the development of effective relations between municipal and First Nations governments and Aboriginal Communities on a range of issues including self-government, treaty and claims implementation, taxation and service agreements, planning notification and economic development.
