- a) Community Planning & Housing Committee
Re: Zoning Boundary Adjustment of 4200 - 4300
blocks of Boundary Road and portion of the
3700 block of Spruce Street

The Community Planning & Housing Committee submitted a report outlining results of a consultation process concerning a proposed zoning boundary adjustment in the Boundary Road/Spruce Street area. Considering the high degree of support by those with properties located on the 4200 - 4300 blocks of Boundary Road and the southside of the 3700 block of Spruce Street that are currently zoned R4 and R9 for a zoning boundary adjustment to the R5 District, the Committee recommended that the proposed boundary adjustment be advanced to a formal area rezoning process. Secondly, given the very strong feelings of those who feel that they would be losing development potential by a rezoning that removed their RM3 designation, the Committee recommends that this portion of the zoning boundary adjustment not be pursued at this time.

The Community Planning & Housing Committee recommended:

1. THAT Council initiate an area rezoning of the 4200 block of Boundary Road and a portion of the south side of the 3700 block of Spruce Street to the R5 District as outlined in Map 2.
2. THAT the part of the zoning boundary adjustment affecting the lots currently zoned RM3 not be pursued.

The estimated cost of the basic upgrading that would permit the building to be utilized as a community centre is \$840,000. The Federal/Provincial program would provide up to one third of the eligible costs of the project (\$280,000).

Cellular Antennae Monopole

4. **Purchase of Parking Meters**

However, the possibility of cooperative tendering for meter equipment with the City of Vancouver represents an opportunity to significantly advance the implementation. The scale economy of a larger cooperative tender should also ensure a better price than either city would realize alone.

1. THAT staff be authorized to participate in a cooperative tender with the City of Vancouver for the purchase of parking meters and revenue collection equipment for implementation of metered parking in Metrotown.
2. THAT a bylaw be prepared to enable the City to control and manage parking through the use of parking meters.

6. NEW BUSINESS

Councillor Rankin

Councillor Rankin advised that he wished to bring forward for Council's consideration a resolution requesting Statistics Canada to consult with the GVRD on census products and services.

MOVED BY COUNCILLOR RANKIN:

SECONDED BY COUNCILLOR JOHNSTON:

"THAT

WHEREAS development of municipal and regional plans across Canada (such as the GVRD's Livable Regional Strategic Plan) relies heavily on comparative trend analysis of key variables from Census to Census;

WHEREAS Census dwelling type and household information, particularly occupied dwellings by structural type and average household size, is of vital importance for all member municipalities of the GVRD in their work toward meeting the objectives of the Livable Region Strategic Plan;

WHEREAS information on dwelling type was collected on a 100 percent sample basis by enumerators, but the decision was made unilaterally by Statistics Canada without prior consultation with the GVRD or its member municipalities to only enter the data on a 20 percent sample basis;

WHEREAS, now that dwelling and household data will be derived only from the 20 percent sample of the 1996 Census rather than the 100 percent sample data used in previous Censuses, the data will be less reliable and more difficult to use for comparative purposes with historical census data;

AND WHEREAS Statistics Canada is considering conducting the 2001 Census by mail rather than by trained enumerators which could result in less reliable data concerning the classification and coverage of the number of dwelling units;

BE IT RESOLVED THAT the Federation of Canadian Municipalities strongly urge Statistics Canada to consult with the GVRD, its member municipalities and other local governments across Canada before any major decisions are made on the 2001 Census that would affect Census products and services available to our communities.

AND BE IT FURTHER RESOLVED THAT the Federation of Canadian Municipalities request Statistics Canada to reconsider its previous decision to only enter information on dwelling type on a 20 percent sample basis and to enter it for all returns on a national basis, or alternatively on a Provincial or regional basis where it is deemed to be of extreme importance."
