Additional Information: The 1997 - 2001 Capital Program includes provision for costsharing with private development for water system improvements, such as looping to eliminate dead-ends and over-sizing existing mains, not directly related to the proposed development. The program takes advantage of the development process in providing a cost effective solution for upgrading the infrastructure. Sufficient General Revenue funds are available and these expenditures are included in the 1997 Water Utility component of the 1997 - 2001 Capital Program.

Additional Information: The 1997 - 2000 Capital Program includes a provision of \$40,000 to continue a program of accessibility initiatives that would permit persons with mobility disabilities to use civic facilities more fully. Proposed improvements include creating six designated parking spaces close to the entrance at Swangard Stadium; upgrading wheelchair ramp access at Kingsway Branch Library; and renovations to create wheelchair accessible washrooms at Burnaby Heights Community Resource Centre and Burnaby Village Museum. Total cost of the proposed improvements is estimated at \$40,000. Sufficient General Revenue funds are available and these expenditures are included in the 1997 City Buildings component of the 1997 - 2001 Capital Program.

60-32-106 Drainage Improvement Program (1997)

Additional Information: Appearing elsewhere on Council agenda is an item recommending award of Contract #9713, The 1997 Drainage Improvement Program. This work order provides funding for Contract #9713 and other ancillary works by City forces. Total project cost is estimated at \$538,000. Sufficient General Revenue funds are available and these expenditures are included in the 1997 Storm Drainage component of the 1997 - 2001 Capital Program.
