#### CARRIED UNANIMOUSLY

a) **Mr. Nick Cuff**, 6233 - 9th Avenue, Burnaby appeared before Council expressing his opposition to Burnaby Business Park's proposal to remove 52 acres from the Agricultural Land Reserve within Burnaby's Big Bend area. Mr. Cuff showed a slide presentation displaying the agricultural lands in the Big Bend area. Contrary to being told the lands were unfit for farming, Mr. Cuff advised that the subject lands were highly productive and employed numerous people.

Councillor Redman arrived at the Council meeting at 7:13 p.m. and took her place at the Council table.

In concluding his presentation, Mr. Cuff advised that he did not see any merit in the proposal to develop the last undeveloped area in Burnaby and strongly urged Council to oppose the rezoning application when it comes forward.

b) Mr. Ricardo Nardelli, Urban Development Institute, Pacific Region, 717 W. Pender Street, Vancouver, B.C. appeared before Council to discuss issues relating to Bill 44 -Labour Legislation. The speaker advised that the proposed legislation has been withdrawn temporarily in order to allow for a public consultation process. Mr. Nardelli stressed that the consultation process must be open and fair as the legislation will have a detrimental effect on union and union trades and will rob workers of their democratic right to the union of their choice. Mr. Nardelli indicated that the legislation which proposes major changes was initially put forward with no consultation. Now that the legislation has been withdrawn in order to allow for this process, the speaker indicated that Urban Development Institute intends to take a very active and vocal role and urged Council to do the same. Mr. Nardelli stressed the importance of Council having a full understanding of the issues and the severe impact the legislation will have on industry and the community.

Mr. Emilio Salituro, 728 Austin Avenue, Coquitlam, B.C. appeared before Council c) advising that he was the owner of a restaurant located at 4277 Kingsway and was appearing before Council to oppose the Burnaby Smoking Bylaw which has been in place since 1997 March. Mr. Salituro advised Council that, in his opinion, the initial shock of the bylaw has since passed and his clientele have not returned to his restaurant. This has resulted in the loss of many dollars in sales and the loss of good staff whose hours have been cut.

In concluding his comments, Mr. Salituro advised that his restaurant will not survive until December of this year and therefore pleaded with Council to amend the bylaw to permit a smoking area in his restaurant until such time as the entire issue is dealt with on a level playing field throughout the lower mainland.
