#### CARRIED UNANIMOUSLY

a) Ms. Johannah Pilot, Supervisor of the Human Resource Centre, Burnaby/New Westminster and Ms. Bhinder Sajan, Employee Officer appeared before Council to provide information on the student placement services provided by Human Resources Development Canada.

Ms. Sajan advised that the program started out as a pilot project in 1968 with a concept of students helping other students find jobs. The primary activity is a labour exchange to meet summer employment needs for students returning to school in the Fall and unemployed youth. The program is funded by the Federal government and services are promoted through local media, local business organizations and by visiting local businesses.

In concluding their presentation, the delegation indicated that the Human Resources Centre for Burnaby/New Westminster is facing a very challenging Summer because job availability has decreased and therefore, they are requesting Council's support for the program and urging they send the message that the Centre is open for business.

Councillor Corrigan arrived at the Council meeting at 7:17 p.m. and took his place at the Council table.

Arising from consideration of the delegation's presentation, Council requested that an article be placed in the next edition of Information Burnaby promoting the "Hire a Student" program in Burnaby.

b) Mr. Victor Stusiak, 8338 Hollis Place, Burnaby appeared before Council on behalf of Mr. Tomo Bulic, owner of property located at 4641 Grafton Street regarding a proposed property subdivision.

Mr. Stusiak read from a prepared brief which is available on file in the City Clerk's Department.

Mr. Stusiak discussed the conditions set out for Subdivision Reference No. 62/97 for 4541 Grafton Street which he considers to be excessive and unfair. The delegation advised that the proposal comprises a two lot subdivision consistent with the standard to Booth Avenue and Grafton Street and that development of the road and storm sewers would be at a later date in conjunction with the properties on Booth Avenue and/or Grafton Street.

In concluding his presentation, Mr. Stusiak requested the following:

- 1. That members of Council visit the site and the total block where the subdivision is proposed.
- 2. That Council review whether or not the lane requirement is valid.
- 3. That Council delete the requirement to construct the lane if Council determines that the lane allowance is required.
- 4. That Council delete the requirement for storm drainage. Drainage to be equivalent to present situation in the block face on Booth Avenue and Grafton Street.

- 5. The City Solicitor provide a clear definition as to the legal applicability for a parkland development cost charge to subdivisions containing up to four dwelling units.
- 6. That the widened Booth Avenue be finished with gravel shoulders and ditch from existing paved roadway to the new eastern property line of lot 2.
- 7. If City subdivisions servicing requirements are applied to all R2 lot subdivisions in single and R2 family zones, and if not, why not?

Ms. Harris discussed the need for student employment, particularly in low income families and advised that part-time employment in the restaurant industry is an important part of their employment options.

In concluding her comments, Ms. Harris acknowledge that second-hand smoke is bad for children but reminded Council that poverty is worse. The speaker stated that she holds City Council responsible for the decline in the local restaurant industry and suggested that the assumption that the Burnaby Smoking Bylaw will protect children is self-righteous and has caused considerable emotional and economic stress to her family.
