Mr. J.S. Fair, President and CEO of the Simon Fraser Health Region appeared before Council and introduced all members present who comprise the Executive of the Board. Mr. Fair provided a video presentation briefly outlining health care and the formation of the Simon Fraser Health Region.

Councillor Corrigan arrived at the Council meeting at 7:08 p.m. and took his place at the Council table.

Councillor Redman arrived at the Council meeting at 7:09 p.m. and took her place at the Council table.

Mr. Fair, in his presentation discussed the Simon Fraser Health Region's geography, statistics on hospital utilization across the country and statistics on acute care beds throughout the region. In concluding his comments, the speaker suggested that the reorganization of health care will provide the best, most comprehensive and integrated health care system.

Ms. Joanne Konnert, Vice President of Acute Care Services, Simon Fraser Health Region addressed Council to provide an update on the acute care services review.

With the assistance of a slide presentation, Ms. Konnert advised that a review of acute care services is being conducted in order to provide opportunities for re-investment, to enhance programs that prevent illness and help maintain patients in their own community and also, programs that retain the ability to care for an increased population. In terms of scope, the speaker advised that all programs offered will be reviewed in order to ensure the most efficient way to deliver health care services while at the same time reducing the need for capital investment.

Arising from the presentation, Council requested that the Simon Fraser Health Region Board give consideration to upgrading the emergency ward at Burnaby Hospital, to bring community groups into the health care services fold, to pay particular attention to home care services and a new funding formula to address the current inequities across the system.

a) Mrs. Marion Herring, 5637 Booth Avenue, Burnaby appeared before Council as a long time resident, volunteer and life time member of the Burnaby Art Gallery Association. Mrs. Herring advised that her purpose for appearing before Council was to correct a misconception regarding the acquisition of the collection of prints that belong to the Burnaby Art Gallery Association.

Mrs. Herring provided Council with a brief history regarding the establishment of the picture rental program which proved to be very successful over the years. The speaker advised that first and foremost the picture rental program was to support local artists and secondly, it was to be educational and provide much needed revenue to the Art Gallery. The speaker stated that at no time was Burnaby taxpayer money used to purchase art for the rental program and that the success of the gallery collection is owed entirely to the efforts of volunteers gifts from artists, gifts from donors, purchase awards from shows and cultural grants.

In concluding her comments, Mrs. Herring stated that she believed an ideal art gallery should be "uptown" where it could be easily found and enjoyed. The speaker requested that Council consider a move towards an accredited art gallery.

Ms. Laura Wee Lay Laq appeared before Council on behalf of *Friends of the Burnaby Art Gallery Association* and as a long time resident of Burnaby.

Ms. Wee Lay Laq advised that she is a local artist who not only shows locally but nationally and internationally and wished to share with Council an "arms length" concept for the Burnaby Art Gallery in terms of working relationships and governance. The speaker outlined the composition and reporting structure of the Burnaby Art Gallery Association in comparison to the new proposal.

In concluding her comments, Ms. Wee Lay Laq suggested that in order to acknowledge visual arts there needed to be a commitment from the City to support an "arms length" organization.

- b) Ms. Ana Coady, Traffic Engineer with Reid Crowther, 4170 Still Creek Drive, Burnaby appeared before Council in support of a 225 signature petition to allow on-street parking on Still Creek Drive between Gilmore Diversion and Willingdon Avenue. Ms. Coady advised that her purpose in appearing before Council was to request that the parking restrictions on Still Creek Drive be removed and that Council give consideration to the following options:
 - Implement measures to encourage the use of alternate modes of travel: improve the frequency and routing of transit service in the area, build new side walks between Still Creek Drive and Canada Way and Lougheed Highway, extend the City's bicycle network to include the Still Creek area.
 - Implement land use planning policies to encourage more compact and affordable communities where people can commute less and live close to employment centres.
 - Allow on-street parking (minutes from the proceedings of the October 18, 1993 Council meeting show that City staff identified approximately 70 spaces between Gilmore and the bridge west of Willingdon).
 - To preserve the esthetic presentation desired by Slough Estates, require that Slough Estates provide for 70 free parking spaces as a condition of further development. Accessibility and availability of the sites should be comparable to that of street parking. Parking may be incorporated into the new buildings slated for completion next year or made available on vacant land along Still Creek Drive.

c) Mr. John Scott, Architect and Mr. Renato Bordignon, Property Manager, both representing Slough Estates, 4260 Still Creek Drive, Burnaby appeared before Council to clarify confusion that has arisen as a result of the request to allow on-street parking on Still Creek Drive between Gilmore Diversion and Willingdon Avenue.

The speakers outlined Slough Estates' policies with respect to the allocation of parking for tenants and employees and advised that since 1993 they have received no complaints from tenants regarding the availability of parking space. The speakers indicated that Slough Estates has gone to great lengths to not only implement but maintain high landscaping standards and in the process have ensured that all surface parking is heavily screened from the road. Further, an investigation conducted has indicated that there are a large number of stalls vacant in the underground parking area and that surface parking continues to maintain a high percent of availability.

All new loop detector installations use the bicycle sensitive circular loop configuration. Staff have contacted Mr. Wuschke and apprised him of the circumstances of the work carried at at this intersection, as well as our monitoring and evaluation of new improved detector standards.
