a) **Frank Helden**, #210 - 5895 Kincaid Street, Burnaby appeared before Council to advise of his opposition to the Burnaby Smoking Bylaw.

Mr. Helden read from a recent newspaper article which opposes the smoking bylaw and suggests that a referendum on the issue would be appropriate and should be scheduled for the 1999 Local Government Election.

Councillor Corrigan arrived at the Council meeting at 7:15 p.m. and took his place at the Council table.

b) Robert Buchko, 5924 - 10th Avenue, Burnaby appeared before Council to address the staff report pertaining to the issue of train whistling in the early morning hours. Mr. Buchko advised that he is seriously concerned about his health and that of his family and will continue to protest against the CP Rail train whistling for as long as it takes to resolve the issue.

In concluding his comments, Mr. Buchko suggested that, in order too address the problem, Council contact CP Rail to determine if they would be able to reschedule their trains to a more decent hour; consider the installation of gates and finally, the enactment of an antiwhistling bylaw.

Councillor Volkow retired from the Council Chamber at 7:30 p.m.

c) **Mr. Richard Walker,** Winchelsea Estates Strata Council, 3183 Esmond Avenue, Burnaby appeared before Council accompanied by Mr. Bob Morgan, of the Security Committee to address concerns regarding the operation of Starlite Billiards and the effect that operation is having on the residents of Winchelsea Estates. The delegation advised that they represented 250 owners at Winchelsea Estates and that the break and enters and vandalism in and around their complex has become out of control. The residents are very angry and frustrated and it is estimated that \$40,000 to \$80,000 has been spent, through various insurance claims and repairs as a result of the criminal acts against their property.

Councillor Volkow returned to the Council Chamber at 7:38 p.m. and took his place at the Council table.

The speaker further noted that \$15,000 has been spent on new security measures which have met with limited success.

In concluding his comments, Mr. Walker noted that the majority of problems occur between the hours of midnight and 5 a.m. and questioned why Burnaby is not prepared to deal with this type of problem.

7. <u>NEW BUSINESS</u>

Councillor Johnston

Councillor Johnston advised that he had received notification that a large neighbourhood in the Edmonds area had not been enumerated for the Federal election. Councillor Johnston encouraged Burnaby citizens, who have not been enumerated, to contact their local Returning Officer and register for the forthcoming Federal election.

Councillor Redman

Councillor Redman informed Council of a recent newspaper article which referred to a report from the head of the earthquake team at the Pacific Geo-science Centre which discussed the earthquake experienced in the Lower Mainland last year. Mr. Jerry Rogus and his staff would like to do a more detailed geological survey of lands but funding is not available for this study.

Council requested a staff report providing information on this matter.

Councillor Redman further advised of another article pertaining to the subject of earthquakes where a new multicultural version of the pocket-sized Earthquake Survival Guide has been released and will be available free-of-charge through local community groups. Councillor Redman requested staff to determine if these new guides would be available in Burnaby.

Councillor Volkow

Councillor Volkow advised that he had attended an organized meeting of Block Watch in the Garden Village area and was very pleased with the process and dialogue between the residents and the R.C.M.P. Community Liaison Officer. Councillor Volkow encouraged all Burnaby citizens to join a Block Watch program and become more aware of what is taking place in their neighbourhood.

Councillor Lawson

Councillor Lawson advised that she had the pleasure of attending the Burnaby Health Department's Volunteer Recognition luncheon. Two hundred and fifty seven volunteers came out to the event and Councillor Lawson commended all 334 volunteers for their service to the community.

Councillor Rankin retired from the Council Chamber at 10:45 p.m. and did not return to the meeting.

Councillor Lawson further advised that she had the pleasure of attending the Burnaby Rhododendrum Society function which was attended by over 4,000 people. The Society hosted a number of indoor and outdoor events and raised \$1,000 at their auction.

His Worship, Mayor Drummond

His Worship, Mayor Drummond advised that he attended the "Youth Week" kickoff event at Club Metro this past Sunday. The Club offered a very professional and enjoyable display and Mayor Drummond congratulated the participants for a very successful event.
