## CARRIED UNANIMOUSLY

a) Mr. Tony D'Alessandro, 3171 Sylvia Place, Coquitlam appeared before Council as a Burnaby restaurant owner and extended his apology for his emotional behaviour at the regular Council meeting held on 1997 March 03 at which time the Burnaby Smoking Bylaw was being discussed. However, Mr. D'Alessandro advised that he could not apologize for his anger and fear that the newly imposed smoking regulations will destroy his restaurant business. Mr. D'Alessandro outlined the difficulties that restaurant owners have been subjected to over the past few years, specifically the GST, increased property taxes and now the Burnaby Smoking Bylaw. The writer advised that his restaurant employs 8 people and at this point he will be unable to receive any applications for summer employment due to the slow down in his business.

Councillor Corrigan arrived at the Council meeting at 7:08 p.m and took his place at the Council table.

Councillor Redman arrived at the Council meeting at 7:10 p.m. and took her place at the Council table.

In concluding his comments, Mr. D'Alessandro acknowledged smoking is definitely a health issue but felt that until such time as every district has the same smoking regulations, it is not fair to the Burnaby restaurant owners.

b) Ms. Helene Henrichsen, 3928 Marine Drive, Burnaby appeared before Council accompanied by her husband, Mr. Steve Henrichsen to discuss her home-based business located at 3928 Marine Drive. Ms. Henrichsen reminded Council that she is a registered nurse providing a valuable and difficult to find service to the citizens of Burnaby and the Lower Mainland and that her service supports the Ministry of Health's mandate to send patients home from the hospital early and decentralize health care.

Ms. Henrichsen addressed questions from members of Council following her first presentation on 1997 February 08 and then presented the following recommendations to Council for consideration:

- 1. That Council and staff recognize The I.V. League is compromised solely by a registered nurse operating a small, part-time, private health practice that already complies with the Burnaby Zoning Bylaw. The business does not generate sufficient revenue to sustain a commercial location and to ask her to relocate to a commercial location is to ask her to close down.
- 2. That a single anonymous complaint made against a respected, long-time Burnaby citizen should not be grounds enough to threaten that citizen's livelihood.
- 3. That Council direct staff to issue a licence to the I.V. League at 3928 Marine Drive, monitor as they would any home-based business and respond appropriately if there are any further legitimate complaints.
