### CARRIED UNANIMOUSLY

a) Mr. Harold Brown, President of Burnaby Mountain Senior Men's Golf Club, residing at 2634 Brewster Drive, Coquitlam, B.C. appeared before Council and presented a cheque in the amount of \$16,000 to support the Parks And Recreation Commission Junior Golf Programme. Although Mr. Brown is no longer a resident of Burnaby, he advised Council that he had spent seventy years of his life as a North Burnaby resident. Mr. Brown congratulated Burnaby on the ongoing upgrades to Burnaby Mountain Golf Course and expressed his pleasure with the excellent relationship shared with Mr. David O'Connor, Burnaby's Golf Service and Operations Manager.

**Mr. Merrill Gordon**, Vice President of Burnaby Mountain Senior Men's Golf Club, residing at 1795 Blaine Avenue, Burnaby appeared before Council and proudly announced that the golf club has a twenty eight year history in Burnaby. Through the proceeds of a recent casino night, the golf club raised in excess of \$16,000 to support junior golf in all of Burnaby's golf venues. Mr. Gordon proposed that two thirds of the cost of the Junior Golf Programme be subsidized through this contribution and further that the fees be paid for a group of some thirty juniors who cannot afford to play golf. Further, Mr. Gordon suggested that twenty five juniors, in that same category, will receive golf clubs.

b) **Mrs. Les Lee Lowe**, Chair of the Burnaby Public Library Board, 7508 Government Road appeared before Council to present the Public Library Board's 1997 annual report. Mrs. Lowe was accompanied by Mr. Paul Whitney, Chief Librarian and three members of the Burnaby Public Library Board. Mrs. Lowe advised that in 1997 over 1.8 million user visits were made to library branches with over one million visits to the Bob Prittie Library Branch alone. The Bob Prittie Metrotown Branch is the second most heavily used library branch in B.C. and the twelfth most heavily used public library branch in North America in terms of items borrowed. The speaker further advised that the most important event of the year took place in October when the formal process to replace the McGill Branch was announced. Mrs. Lowe extended an invitation to Council and all Burnaby residents to attend the public meeting on June 03rd to consider siting options for this new library facility.

In concluding her comments, Mrs. Lowe thanked Council for its continued support and acknowledged the dedication and hard work of library staff.

c) Mr. Matthew Liang, 8385 Roseberry Avenue, Burnaby appeared before Council to discuss the 1600 ft. addition to his residence which was constructed without permit or approvals by the previous owner. Mr. Liang advised that he is currently involved in matrimonial litigation concerning the ownership of the property and that, as a result of marriage separation, he and his two small children reside in the home. The speaker contended that, should Council place notice in the Land Title Office stating that the property is in contravention of City Bylaws, it will have a very serious impact on his ability to remortgage. Mr. Liang stated that he had no intention of selling the property as it is the family home and that his five year mortgage would be expiring in a couple of months.

In concluding his presentation, Mr. Liang sought Council's understanding regarding the hardship he would be facing should a notice be filed on his property.
