Additional Information: The City has an ongoing program to reduce infiltration and inflow in the sanitary sewer system. The program has an important element in the regional Liquid Waste Management Plan as it has the major advantage of reducing the load on sewage treatment plants. The main focus of this year's schedule will utilize a combination of video inspection and flow monitoring techniques to identify specific sections of the sewer network requiring rehabilitation. Cost of the program is estimated at \$150,000. Sufficient General Revenue funds are available and these expenditures are included in the Sanitary Sewer Utility component of the 1998 - 2002 Provisional Capital Program.
