 Ms. Pam Ryan, Marketing Coordinator and Mr. Pat Cruikshank, Project Manager, Trans Canada Highway (HOV) Project appeared before Council to provide information on the implementation of HOV lanes along the Trans Canada Highway.

Councillor Volkow entered the Council Chamber at 7:05 p.m. and took his place at the Council table.

Ms. Ryan provided background information on the \$60 million dollar project and advised that the HOV lanes will be open to vehicles with three or more passengers. The passenger limits will be enforced seven days per week, 24 hours a day. Violation of the passenger requirements will result in a fine of \$98.00 and two points on an individual's drivers license.

It is hoped that use of the HOV lanes will promote fuel and parking cost savings. She advised that the HOV project is not about reducing traffic congestion, but its goal is to reduce the rate of congestion growth.

The Ministry of Transportation and Highways is working with the Jack Bell Foundation and Go Green Transit to assist in the formation of van and car pools to use the HOV lanes.

Currently, a communications program is underway using a Youth Employment Program to distribute brochures and information in area shopping malls and throughout the community. In addition, an advertising campaign will be undertaken in lower mainland communities.

Arising from the discussion, His Worship, Mayor D.P. Drummond requested the delegation advise the Ministry of Transportation and Highways that Burnaby Council is extremely concerned about noise attenuation along the Trans Canada Highway; particularly along the south side of Burnaby Lake Park and the residential districts abutting the freeway.

Ms. Ryan advised that she will take Council's concerns back to the appropriate officials at the Ministry of Transportation and Highways.

b) Mr. Victor Stusiak, Chair, Action Line Housing Society appeared before Council to request a property tax exemption for Overlynn Mansion.

Mr. Stusiak provided Council with a copy of Section 342 of the Municipal Act of B.C. which outlines Council's authority for granting property tax exemptions for "eligible heritage property".

The speaker provided background information on the application advising that the only reason for maintaining this building is for its heritage value. In addition, Mr. Stusiak outlined the financial status of the Action Line Housing Society noting a shortfall between revenue and operating costs which would be off-set by the assistance of a property tax exemption.

In conclusion, the speaker requested a property tax exemption in the amount of \$3,900.00 for the Overlynn Mansion.

c) Mr. Robert Cheung, 3887 Piper Avenue, Burnaby, B.C. appeared before Council to address a staff report regarding alleged bylaw contraventions at the subject address.

Mr. Cheung advised that the area annotated by Burnaby City staff as a drainage ditch, has been classified as a low lying area by the Department of Fisheries and Oceans.

The speaker noted that drainage problems occur on his property, and water accumulates in this area as a result of subdivision to the north and south of his property.

Mr. Cheung advised that he would like Council to provide him with further information on water movement in relation to the site.

The pavement standard of 8.5 metres for both the 4300 block and the 4400 block of Oxford Street was defined by the City prior to the adoption of the Burnaby Transportation Plan. As LIP requests for both of these blocks pre-date the Burnaby Transportation Plan, and as the 4400 block Oxford is already constructed to an 8.5 metre pavement width, it is recommended that in the interests of equitable treatment for both blocks, the LIP for the 4300 block be allowed to proceed for construction as part of the 1998 Local Improvement Program. The City Manager recommended:

1) **THAT** Council approve the inclusion of the 4300 block Oxford Street in the 1998 Local Improvement Program.

Staff recommend that rather than close the walkway, City officials contact Burnaby North Secondary School Officials to try to resolve the problems when school resumes in September.
