PURPOSE:

The purpose of this report is to set the Council, Committee

meeting and Public Hearing schedules for 1999.

#### **RECOMMENDATION:**

1. THAT Council approve the Council, Committee meeting and Public Hearing schedules for 1999 as set out in this report.

#### REPORT

In previous years it has been customary for Council to set regular meeting dates for Council and Committee meetings for the forthcoming year. In keeping with that practice the attached schedules set out Council and Committee meeting dates which try to avoid conflicts of date and time for Council members attending these meetings.

The dates also take into consideration the policy changes adopted by Council in 1994 December with respect to holding three Council meetings per month, meeting on an alternating basis twice per month during July and August, holding In Camera meetings at 6:30 p.m. in the Council Committee Room, not holding Committee meetings in July and August and establishing bi-monthly schedules for the Economic Development Committee, Community Issues and Social Planning and Bicycle Advisory Committee. Consideration has also been given to avoid conflicts with the FCM and UBCM annual conferences. It is recognized that adopting this report does not preclude Council from making any additions, deletions or changes as the year progresses or in order to accommodate changes arising from the 1999 Committee appointments.

The Public Hearings proposed in this report for February, April, June, August, October and December 1999 will deal with the most recent group of rezoning applications forwarded for consideration under the usual bi-monthly reporting schedule. The Public Hearing dates in January, March, May, July, September and November would be available for other cases such as those previously being processed, and if it is found unnecessary to hold a Public Hearing in these months, the scheduled hearing would be cancelled.

Council has in the past approved consideration of special Public Hearings for specific rezoning requests that have not corresponded to the scheduled dates. Unless otherwise directed, the Planning and Building Department will pursue consideration for similar extraordinary cases that may occur in the forthcoming year, as required.

It is important to note that meetings have not been scheduled in Committee rooms 1 and 1A as this room is being used for election purposes in 1999.
