ASPHALTIC CONCRETE & ASPHALTIC CONCRETE GRINDING

PURPOSE:

To obtain approval to award a contract for machine laid asphalt and asphalt grinding.

## **RECOMMENDATION:**

1.

THAT a contract be awarded to the lowest bidder, Jack Cewe Ltd., for machine laid asphalt and asphalt grinding at various locations throughout Burnaby for a total cost of \$1,699,554.01 with final payment based on actual quantities and unit prices tendered.

## **REPORT**

Five tenders for this contract were received by the closing time of 3:00 p.m., Monday, 1998 April 27 and were opened by staff in the presence of representatives of the firms bidding. A tabulation of the tenders received is <u>attached</u> (Attachment A).

The work of this contract involves the supply of all labour, materials, tools, plant and equipment required for the grinding of approximately 75,000 square meters of existing asphalt, the laying of approximately 19,000 tonnes of asphalt and other miscellaneous work at various locations throughout Burnaby.

The Director Engineering's estimate for this work is \$1,763,000.

The recommended bidder, Jack Cewe Ltd., has satisfactorily completed numerous contracts for the City. Based on their past performance, the Director Engineering is satisfied that they have the experience and resources to complete the work of this contract.

Sufficient General Revenue and Capital Reserve funds are available and this project is included under various 1998 Provisional Operating and Capital Budget accounts. Appearing elsewhere on this agenda is a report requesting approval of the 1998 Pavement Overlay Program which is included under the 1998 Street and Lane Rehabilitation component of the 1998-2002 Provisional Capital Program.

The Director Engineering concurs with the above recommendation.
