MOVED BY COUNCILLOR EVANS: SECONDED BY COUNCILLOR LAWSON:

"THAT the delegations be heard."

CARRIED UNANIMOUSLY

A) Mr. George Evens, Managing Director of the North American Council of Advocates for Creatures - Land, Air and Water and residing on McCrae Avenue in Mission appeared before Council to request the introduction of a Cat Spay and Neuter Bylaw in Burnaby similar to those already passed in the Cities of Coquitlam and Surrey and currently being considered by North Vancouver and Delta. Mr. Evens suggested that there was a more humane way to deal with

the serious problem of unwanted cats than to continue killing upwards of 1.5 million animals in Canada per year, approximately 370 in Burnaby. The speaker advised that he felt disposed to approach Council directly as it is only Council that can enact needed spay/neuter/identification/breeder permit bylaws that will stop the growth of unwanted litters of cats, or reduce the current surplus and eventually eliminate the need to kill defenceless cats.

Councillor Redman arrived at the Council meeting at 7:03 p.m. and took her place at the Council table.

Councillor Rankin arrived at the Council meeting at 7:04 p.m. and took her place at the Council table.

In concluding, Mr. Evens also requested that Council consider constituting a committee to review and discuss the proposal and that his organization is prepared to work with that committee and become a part of the solution towards the elimination of killing healthy cats.

Mr. David Knowles, #314-6577 Royal Oak Avenue, Burnaby appeared before Council as the Regional Director/Research and Media for the North American Council of Advocates for Creatures - Land, Air and Water to speak in support of the enactment of a spay/neuter bylaw in Burnaby. Mr. Knowles provided a review of the extensive lobbying that has taken place over the past four years to put a stop to the unnecessary killing of healthy cats.

In concluding his comments Mr. Knowles invited Council to visit the Norland Avenue SPCA shelter in Burnaby on a busy day in order to observe the extent of the problem at hand. On average, one cat is killed in Burnaby every day.

PRESENTATION

Burnaby Clef Society 50th Anniversary Celebration Presenters: Nancy Gobis, Past President Eileen Fletcher, Recording Secretary

Ms. Eileen Fletcher, Recording Secretary of the Burnaby Clef Society presented Council with a brief history of the Burnaby Clef Society in recognition of its 50 year anniversary. Ms. Fletcher advised that, since 1949, Burnaby has been blessed with a remarkable number of musically talented individuals, particularly young people, who have gone on to pursue a successful musical career. Further, Ms. Fletcher detailed numerous events that have taken place over the years.

Ms. Nancy Gobis, Past President of the Burnaby Clef Society apprised Council of the many successes with respect to the young people who have actively participated with the Society and invited Council to attend any one of the festivals annually hosted by the Burnaby Clef Society. In concluding her presentation, Ms. Gobis extended an invitation to Council and the citizens of Burnaby to join with them in celebrating the Burnaby Clef Society's 50th Anniversary on Sunday, February 7th at 2:00 p.m. at the Shadbolt Centre for the Arts.

B) Mr. Earl Smith, 555 - 6th Street, New Westminster, B.C. appeared before Council on behalf of New Westminster Bingo Society, operating as Royal City Bingo. Mr. Smith advised that Royal City Bingo has been in the same location for the past ten years and has a compliment of 51 employees, funding approximately 80 charities. Mr. Smith advised that his purpose for appearing before Council was to express his dismay with the way in which the Provincial Government has conducted the bingo licencing process and to object to a bingo licence being granted for Middlegate Mall which he felt was located too close to Royal City Bingo Hall in New Westminster. In concluding his comments, Mr. Smith advised that New Westminster Bingo Society is not trying to be greedy but rather, only want to survive.

Mrs. Chami's first concern related to Lot A in Discovery Park which is located west of Gilmore Way. Mrs. Chami advised that she had recently discovered that a construction crew has pumped their liquid construction waste into the creek running through Lot A which is just north of the Hong Kong Bank. The creek runs into Still Creek and therefore, the speaker inquired as to how incidents such as this would be prevented in the future.

Mrs. Chami also reminded Council that the Friends of Discovery Park, Citizens Advisory Committee do not support or approve any kind of fencing of any height anywhere in Discovery Park. The idea of fencing is contrary to the guidelines in the Discovery Park Community Plan.

In concluding her comments, Mrs. Chami expressed her concern about the health of Still Creek. The speaker questioned how Council will protect Still Creek habitat and what plans are in place to stop the continued pollution of the creek.

Councillor Volkow returned to the Council Chamber at 8:09 p.m. and took his place at the Council table.

"We urge all levels of government to declare homelessness a national disaster now, as a first step in implementing a National Homelessness Relief and Prevention Strategy, both short-and-long term."

- 2. THAT Burnaby City Council take the following actions proposed by Toronto as part of a nationwide effort to address housing and homelessness:
 - (a) Call for immediate Federal action on this front, including action on the creation of a senior Federal Cabinet Committee with a clear mandate, and the necessary resources to take action.
 - (b) Endorse the FCM request for a meeting with the Federal Cabinet Committee dealing with housing and homelessness (once it has been determined, and it is in place) to discuss the options document and an Action Plan.
 - (c) Seek to meet with the appropriate senior Ministers in the Vancouver area.
 - (d) Endorse a national Homelessness Issue web site be developed, as part of the FCM web site, with links to good local sites across the county, and including information on local solutions and best practices for housing.
 - (e) Designate a senior policy person from the Housing Centre for input into a "National Housing Policy Options" Team, who will develop within 3 months, a document of real options for national circulation.
 - (f) Ask the FCM to put the critical issue of housing and homelessness on the agenda of a full FCM plenary Session, at the 62nd Annual Meeting of FCM (June 4-7, 1999), in Halifax.
- THAT Burnaby City Council authorize Planning and Building department staff to take part in meetings and discussions about homelessness in Greater Vancouver.

Councillor Lawson was given leave to introduce the following motion regarding Child Pornography:

Councillor Rankin retired from the Council Chamber at 10:26 p.m. and did not return to the Council meeting.

MOVED BY COUNCILLOR LAWSON: SECONDED BY COUNCILLOR JOHNSTON:

"THAT WHEREAS under Section 163.1(4) of the Criminal Code of Canada it is an offence to possess child pornography

AND WHEREAS a recent British Columbia Supreme Court decision resulted in charges of possession of child pornography being dismissed against a person because Section 163.1(4) of the Criminal Code was deemed to contravene a Canadian citizen's fundamental freedom of thought, belief, opinion and expression, including freedom of the press and other media of communication, granted under Section 2(b) of the Canadian Charter of Rights and Freedoms

AND WHEREAS children and youth are sexually exploited during the production of child pornography materials and such sexual exploitation is both an offence and an infringement on the rights and freedom of children and youth

AND WHEREAS dismissal of such serious charges sends the message to children, youth, potential customers of child pornography materials, the community-at-large, and law enforcement officials that the sexual exploitation of children and youth is acceptable in our society when, in fact, it is not acceptable

AND WHEREAS the British Columbia Supreme Court decision may set a dangerous precedent for future cases against those who would sexually exploit children and youth

AND WHEREAS Canada is a signatory to the *United Nations Convention on the Rights of the Child* which obliges States Parties to undertake to protect the child from all forms of sexual exploitation and sexual abuse

AND WHEREAS the Attorney General for British Columbia is acting to protect children and youth from sexual exploitation in appealing the British Columbia Supreme Court decision

THEREFORE BE IT RESOLVED THAT the City of Burnaby:

- express its strong support for British Columbia's Attorney General in acting to protect children and youth by appealing the British Columbia Supreme Court decision, and
- ii. express its deep concern to the Federal Minister of Justice about the impact of the British Columbia Supreme Court decision, and
- iii. forward a copy of this resolution to the Federation of Canadian Municipalities and the Union of British Columbia Municipalities with a request that similar actions be taken by their respective Boards, and
- iv. forward copies of this resolution to all Burnaby Members of Parliament and Members of the Legislative Assembly."
