MOVED BY COUNCILLOR EVANS: SECONDED BY COUNCILLOR LAWSON:

"THAT the delegations be heard."

CARRIED UNANIMOUSLY

a) Mr. Jazz Sickham, Local Minibus Limited, 320 Industrial Way, Vancouver, B.C. appeared before Council to address issues pertaining to top lights on minibus vehicles. Mr. Sickham indicated to Council that pizza vehicles, tow trucks and driver training vehicles have top lights on their vehicles for the purpose of identification and requested that Council give the same consideration to allow top lights on minibus vehicles.

Further, Mr. Sickham brought forward the issue of "flagging." Mr. Sickham suggested that if a person was standing in front of a commercial building and wanted to go to a particular destination, the minibus service would contact its dispatcher who would then determine whether or not the driver could pick up that fare. The speaker advised that this process is unacceptable to City staff and that this position is not supported by Local Minibus Limited.

In concluding his presentation, Mr. Sickham reminded Council that timing was of the essence and encouraged Council to proceed in recommending an amendment to the Cab and Commercial Vehicle Bylaw to permit minibus transportation services in the City of Burnaby.

b) Mr. Gary Bennett, 1498 Maple Street, White Rock, B.C. appeared before Council as a member of B.C. Government and Service Employees Union Local 1004. Mr. Bennett advised that he is employed as a communications officer for the Ministry of Transportation and Highways. The speaker advised that the purpose for appearing before Council was to advise of the current state of provincial highways and request that Council join other cities in adopting a resolution requesting that the Federal Government formalize a national highway system and also reject the downloading of arterial highways to local government.

The speaker introduced the following resolution for Council's support:

"WHEREAS, many of British Columbia's highways have deteriorated to less than acceptable standards; and

WHEREAS, this deterioration of our transportation system affects our economy and increases safety risks to British Columbians; and

WHEREAS, our highways must not be allowed to continue to deteriorate;

THEREFORE BE IT RESOLVED, that this body urge the Provincial Government to take immediate action to reduce the backlog of highways which are in urgent need of rehabilitation; and

BE IT FURTHER RESOLVED, that this body call on the Federal Government to formally recognize, through an Act of Parliament, a national highway system as endorsed by every province and territory; and

BE IT FINALLY RESOLVED, that this body reject any attempt to ship the responsibility and cost for provincial roads to local government and taxpayers without consultation and agreement from the affected parties."

In concluding his comments, Mr. Bennett suggested that it will be a challenge to seek solutions to this escalating problem but felt that local government could play a significant role in challenging the higher levels of government to meet their responsibilities. Arising from consideration of the presentation, Councillor Corrigan was given leave by Council to introduce the following motion:

MOVED BY COUNCILLOR CORRIGAN: SECONDED BY COUNCILLOR REDMAN:

"THAT the delegation's resolution be **REFERRED** to the Traffic and Transportation Committee (Transportation and Transit Division) for review and report."

Council requested that the Traffic and Transportation Committee (Transportation and Transit Division) also look at the GVRD report sent to the Federal Government regarding cost associated with the infrastructure which is paid for by the gasoline tax.

Councillor Corrigan retired from the Council meeting at 7:24 p.m.

Councillor Corrigan returned to the Council Chamber at 7:25 *p.m. and took his place at the Council table.*

c) **Mr. Dave Crown**, #170-5665 Kingsway, Burnaby, B.C. appeared before Council on behalf of pub owners to address the 1998 November 16 announcement from the Provincial Attorney General regarding a review of B.C.'s Liquor Policy. Mr. Crown advised that the purpose for appearing before Council was to request that Council support the following resolution opposing the sale of liquor without food by restaurants:

"THAT the City of Burnaby advise the Provincial Government that it opposes changes in liquor licencing laws that would allow restaurants the ability to serve liquor without food."

Mr. Crown indicated that allowing restaurants to serve liquor without food would essentially mean that all restaurants will turn into pubs. The speaker briefly discussed comparisons between pubs and restaurants in terms of liquor regulations and elaborated on the reasons that the regulations are in place.

Arising from the presentation, Councillor Corrigan was given leave by Council to introduce the following motion:

a) Councillor L.A. Rankin <u>Re: Provincial Equalization Grant Elimination</u>

Councillor Rankin was given leave by Council to introduce the following motion:

MOVED BY COUNCILLOR RANKIN: SECONDED BY COUNCILLOR REDMAN:

"THAT WHEREAS, the Provincial Government, by way of a surprising press release just before Christmas, announced the elimination of the remaining Provincial Equalization Grant, effectively deleting \$1.7 million worth of revenue from Burnaby's 1999 Operating Budget, and

WHEREAS, this grant was once (in 1981) \$10.1 million and represented 29% of the Municipal tax levy, and

WHEREAS, this grant has been arbitrarily reduced over time to now zero constituting a downloading of costs and obligations on Burnaby that have to be made up in increased property taxes and/or reduced services, and

WHEREAS, this cut was made without advance notice of consultation despite the Province committing to do so after the major reductions in 1997, and

WHEREAS, this cut came <u>after</u> Burnaby and most other municipalities had set and published their Provisional 1999 Operating Budget, and

WHEREAS, the supposed "sharing" of fine revenues has nothing to do with fine revenues but is instead an arbitrary percentage of policing costs thereby providing less to those municipalities who have carefully controlled these costs, and

WHEREAS, funding to Burnaby from the renewal of the Provincial water/sewer infrastructure program is at the Provincial Government's discretion and does not provide financing for the operating needs of the City, and

WHEREAS, the remaining points of the Minister's "six point plan" are a reiteration of existing programs and do not provide any relief for Burnaby's operating budget needs,

THEREFORE, BE IT RESOLVED THAT,

- 1. The Mayor, on behalf of Council, write the Minister of Municipal Affairs asking her to reconsider the elimination of the Provincial Equalization Grant and to restore it at least for 1999 so that municipalities might better prepare for its possible eventual elimination, and
- 2. Copies of this motion be sent to Burnaby's MLA's, Joan Sawicki; Fred Randall; Pietro Calendino; Christy Clark, and
- 3. Staff be directed to research strategies and means of handling a possible loss of revenue of this magnitude."

Councillor Corrigan returned to the Council Chamber at 9:33 p.m. and took his place at the Council table.

Council agreed to AMEND the resolution by including that the UBCM office and all municipalities and regional districts in the GVRD receive a copy of the resolution and further, that Item 3 of the Resolve be deleted.
