A) Mr. Jim Fraser, Ste. 1704 - 3755 Barkley Court, Burnaby appeared before Council on behalf of the Lougheed Mall Residents Association to express concerns about the Skytrain public consultation process undertaken by the Regional Transportation Project Office.

The residents are requesting Council's support to request the Provincial Government suspend construction of the Lougheed skytrain station until all environmental and crime issues can be addressed. Primarily, the residents are concerned that the Lougheed mall station will experience the same types of problems found at the Metrotown Skytrain station, particularly as the Lougheed station is a three platform station and larger than the Metrotown site. In addition, an adjacent tunnel provided to allow individuals to cross Lougheed Highway safely contributes to criminal activity in the area. Area parents are concerned that criminal activities around the proposed Lougheed skytrain station coupled by the activities already in place in the pedestrian tunnel will create an extreme safety hazard for students travelling to and from Cameron School.

In addition, the Lougheed Mall Residents' Association supports the Stoney Creek Environment Committee concern about the impact of construction during the wet months of January and February on the fish habitat at Stoney Creek.

Therefore, the Lougheed Mall Residents' Association are requesting Council's support to request the Provincial Government delay construction of the proposed skytrain line until drier weather occurs.
